Dear Thurman Town Board,

The following is a report of animal control services for the year 2015. All together for the year 86 calls were reported. These 86 calls are broken down as follows:

- 26 Stray Dog Calls.
- 20 Lost Dog Calls.
- 13 Loose Dog Complaints.
- 6 Animal Neglect Complaints.
- 3 Dog Bite Cases.
- 3 Wildlife Calls.
- 3 Administrative Calls.
- 3 Cat Calls.
- 2 Dog Attacking Other Animal Calls.
- 2 Dog Shooting Calls.
- 1 Dangerous Dog Complaint.
- 1 Dog Abandonment Call.
- 1 Dog Retrieval for Law Enforcement.
- 1 Barking Dog Complaint.
- 1 Possible Animal Theft Call.

Of these 86 calls, 7 total tickets were written for last year, 4 for loose dog complaints, 2 for dog neglect complaints and 1 for no dog license. Also, 21 new dog licenses were created based off complaints. Of the 26 stray dog calls, 10 were unfounded, 13 owners were located and 3 were adopted out. All in all the year was steady with calls and about twice as many calls were seen this year than last year.

Once again I thank the board for continuing my services and look forward to serving again for the 2016 year. Thanks very much.

As a member of the Town Board of the Town of Thurman I am requesting a resolution rescinding the appointment of Gail Seaman as a Town Board Member made on January 4, 2016. We have sworn to uphold the law and that is why I am making this request. I am not attempting to be an obstructionist; rather, I believe that it was improper.

First, upon my recollection of the January 4, 2016 organizational meeting, Gail Seaman was allowed to vote upon her own appointment. However, upon my own research, I have discovered that an Appellate Court, The Third Department, has stated "it would be contrary to public policy to permit the hold-over respondent to vote upon the question of filling the vacancy of his own office" (In re Crosby, 265 AD 92, 93 [3rd Dept 1942].) This opinion has been echoed by the Attorney General who has offered an informal opinion that a public official cannot vote to appoint himself or herself.

I also believe, upon my own research, that the votes of Supervisor Wood, and Town Board member Younglbood were not enough to appoint Ms. Seaman. Again, the Appellate Court has stated:

"Subdivision 5 of section 64 of the Town Law provides that a vacancy in a town office may be filled by 'the town board or a majority of the members thereof. A majority of the Town Board in question here cannot be less than three members thereof. This not only appears from the plain wording of the portion of the section quoted, but is clarified by section 63 of the same law when read in connection with section 64. Section 63 provides, in part, '[e]very act, motion or resolution shall require for its adoption the affirmative vote of a majority of all the members of the town board.' The foregoing does not provide for vote by a majority of eligible members but specifically by vote of all members. Even making allowance for the vacancy caused by the tie in the vote for Councilman in 1941, there were four members of the Board, including respondent as hold-over, when the purported designation of petitioner took place. Clearly, a majority at that

<u>time could not be less than three members</u>."(In re Crosby, 265 AD 92, 93-94 [3rd Dept 1942](emphasis added)).

Gail Seaman is sitting as a board member after improperly voting for herself and without proper majority board approval.

I am asking our Town Board to follow the law and the ethical requirements set forth by our town board. That is all. As suggested by our own Town Counsel, the Town Board should, at the very least, take a conservative approach and wait for a special election or the next general election in the fall of 2016. The other members of our Town Board-cannot continue ignoring our Town Counsel's advice and the law.
