Tonight we approved the purchase of a truck. This was an expected 2018 purchase that was budgeted for. Because we knew that there was money in the budget to buy this truck we approved it.

\$24,336.00 for the supervisor's confidential secretary \$4,000.00 for the deputy town clerk

\$\$11,000.00 for the assessor clerk

All three of these important positions are fully funded

Annual Accounting Meeting January 19, 2018

The reasons money was appropriated for these positions are that they are important and that they are needed in order to adequately serve the Town of Thurman and in order for the officials from the 3 offices to uphold their responsibilities.

At the organizational meeting 3 board members cut all funds for the deputy town clerk and the assessor clerk and cut back the funds for the confidential secretary to the supervisor.

If these three board members can understand that we can buy a truck for the highway department because it was budgeted for THEY SHOULD BE ABLE TO UNDERSTAND THAT WE CAN AFFORD THESE THREE POSITIONS BECAUSE THEY

WERE BUDGETED FOR IN THE SAME WAY THAT THE TRUCK WAS BUDGETED FOR.
