**OLD BUSINESS:** 

Route 28 Bridge cement update: We went back to the contractor and they were indicating that we would take it for free. We declined. They are offering to bring the cement in at \$20 per yard, however they almost doubled the estimate of the amount of cement to 3,600 yards. Not sure where we would put that much concrete. **Councilman Eddy** asked how DEC felt about reinforced concrete in a C & D. Discussion ensued about considering other possible locations and alternative uses.

**Councilwoman Seaman** said the food pantry would like to change the pantry hours to 11:00 a.m. to 1:00 p.m. on Tuesday in hopes of getting a better turn out.

### **Resolution Regarding Records Retention Schedule Adoption**

RESOLVED, By the Thurman Town Board of the Town of Thurman that Records Retention and Disposition Schedule MU-1, issued pursuant to Article 57-A of the Arts & Cultural Affairs Law, and containing legal minimum retention periods for local government records, is hereby adopted for use by all officers in legally disposing of valueless records listed therein.

FURTHER RESOLVED, that in accordance with Article 57-A:

- (a) Only those records will be disposed of that are described in Records Retention and Disposition Schedule MU-1 after they have met the minimum retention periods described therein;
- (b) Only those records will be disposed of that do not have sufficient administrative, fiscal, legal, or historical value to merit retention beyond established legal minimum periods.

WHERAS Warren County has made and additional allocation as part of that agreement for the purchase of equipment which will assist in the reduction of road salt use, and

WHEREAS the town recognizes the value both fiscally and environmentally of reduced salt use on highways within the town, now there fore be it

RESOLVED that the town board authorizes the purchase of a new Viking Proline Heavy Weight Combination Body with Dickey John Control Point as detailed in the attached quotation from Cives Corporation, dba Viking Cives in the amount of forty-three thousand four hundred thirty dollars and thirty cents (\$43,430.30), through the Oneida County Contract #1816 which has been extended to all municipalities statewide and be it

FURTHER RESOLVED that the source of funding for the purchase shall be DA 5130.2 Machinery-Equipment and the budget adjustment as follows:

The bookkeeper will be moved downstairs now that the phone system is done.

**Supervisor Wood** met with the court today. Talked about housekeeping, and catching up on court safety matters. Good meeting. The Judge stayed after court today to meet with the Supervisor.
