Discussion: Supervisor Hyde noted you have saved only \$44,601.00. Where are you going to find the other almost 100,000? Councilwoman Harris noted some people think he has too many employees over there. Maybe he needs to fire a couple. Councilwoman Seaman stated I don't think so Joan. Supervisor Hyde noted the problem is.....The problem is.....Councilwoman Harris noted I don't think that, but I know that people think that. Supervisor Hyde noted the Tax Cap if you can't stay under it you have to override it guys. That is why I wanted to do that Resolution because just in case. Councilwoman Seaman interrupted her noting Cynthia it can be done now if it has too. Supervisor Hyde stated we have to call a Public Hearing. Councilwoman Seaman noted yeah we do. Supervisor Hyde noted then we have too.....I am hoping that there is still time in order to do the process. Councilwoman Seaman noted let's see what this comes out to. **Supervisor Hyde** with all those changes it come out that you still need to cut almost a 100,000 to stay under the Tax Cap. Councilwoman Seaman replied well you know what I think we have some additions to do. Supervisor Hyde noted and that.....To override that Tax Cap, and stay with at least you know kind of like this Budget would have cost 70 cents per 1,000. So if you have a house that was assessed at 100,000 your taxes would go up \$70.00. Councilwoman Seaman replied you offered us a 17.34% increase in taxes. That is what it adds up to. Supervisor Hyde noted you like to make it sound really scary. 70 cents per 1,000 isn't all that scary. And you have to remember that the State of New York has a big chunk of land in Thurman, and they pay a great big huge share of the taxes. Councilwoman Seaman interrupted noting last year......Cynthia (inaudible) taxes never come off. They only get bigger. She continued they pay only what they want to pay, and the point of it is it still ends up 17.34%. So why don't we just do it the way we are supposed to dear. Supervisor Hyde asked and what way is that. Councilwoman Seaman responded the right way by thinking about the taxpayers. Supervisor Hyde noted I don't know where else you are going to cut. You already made all your cuts. Is there any more to cut. Councilwoman Seaman responded Cynthia. Supervisor Hyde remarked 100,000 is a lot to have to cut. I don't know where you are going to find it. Councilwoman Ackley asked where can we go back and make room for or is it may be possible to get the playground equipment. Councilwoman Seaman replied actually that can be budgeted right in the.....That can be budgeted right in the Occupancy Tax because Mike Swan said it could be used for that. Supervisor Hyde stated excuse me what are you going to use the Occupancy Tax for. Councilwoman Seaman replied the playground equipment. It can be used for that. Supervisor Hyde noted you want to cut.....You are trying to stay under the Tax Cap, but you want to buy playground equipment. Councilwoman Seaman replied for kids using Occupancy Tax you bet ya. Supervisor Hyde noted you are trying to find almost \$100,000.00 to cut, but you want to buy playground equipment. That makes a lot of sense. Councilwoman Seaman noted Cynthia what part of Occupancy Tax do you not understand. Like Queensbury uses their

Occupancy we (inaudible). Supervisor Hyde noted what is using Occupancy Tax money for playgrounds have to do with trying to stay under the Tax Cap. Councilwoman Seaman responded actually Occupancy Tax is what the County gives u so it is already OK. Supervisor Hyde noted this is like a joke. It is a total joke. Councilwoman Seaman responded no it is actually budgeting. You haven't done it though. Supervisor Hyde remarked no it is not. It is not budgeting. It is Gail playing more games with the Town of Thurman, and the Town of Thurman will suffer for it because Gail thinks somehow, somehow she gets at Cynthia. Well it doesn't hurt Cynthia, it hurts the whole town. Gail's games have hurt the town for two years, and here she is playing her last game. Councilwoman Seaman interrupted noting Cynthia you are the one who hasn't done anything for the town. Councilwoman Harris asked OK what are we doing here folks. Supervisor Hyde replied playing games. Playing really, really bad games. Councilwoman Seaman noted let's see what we have for .....Well what we can do is we can have another Budget Meeting, but we can also just approve a Preliminary Budget then we have at least the changes we made approved, and we can work from there. Supervisor Hyde asked OK is there any more changes that you want to make in this Budget before we call Preliminary? Councilwoman Seaman responded I think we went line by line. Supervisor Hyde replied you did. OK so are we all set you are going to call this Preliminary. Councilwoman Seaman noted OK now just to put this into perspective right now for the General Fund for the 2020 Budget we have proposed \$539,492.00. Councilwoman Harris asked about the figure, and Councilwoman Seaman repeated it. She continued in the 2019 Budget the proposal was \$573,905.00 so we are actually less than the proposal was for the 2019 Budget. Supervisor Hyde noted also we are going to have people that are going to have to work less hours. People making less pay will work less hours so don't think you are getting something for all these cuts. Cause you are not. You are losing from these cuts. OK, don't be fooled. Councilwoman Seaman interrupted noting no actually it doesn't matter. She continued so once the numbers are done I would like to propose that we at least pass these changes for a Preliminary Budget, and then we have until the end of November to work on this if we......After a Public Hearing if we need to change anything else, and if we need to add or subtract. Supervisor Hyde noted OK you want to call a vote. Roll call. The Town Clerk noted roll call vote to the changes in the budget. Supervisor Hyde noted on the changes that the Board made tonight. Councilwoman Seaman noted to adapt as these as the Preliminary Budget. Supervisor Hyde noted if it passes. Councilwoman Ackley made a comment and **Councilwoman Seaman** noted all's that we are voting on is the changes we made line by line. Councilman Needham noted this is the Preliminary. Councilwoman Seaman noted this is the Preliminary it can be changed at any time before the end of November. The Town Clerk asked OK we ready for the vote. A Roll Call Vote Was Called.

### The Board Voted as Follows: Ayes~3 Ackley, Needham, Seaman, Nays~2 Harris, Hyde

Discussion: Councilwoman Ackley asked if you say no then why didn't you disagree when we were going through the lines. Councilwoman Harris replied I am not going to argue with her (inaudible) idiots. Supervisor Hyde noted we have to call a public hearing, and we are going to pass the Resolution to do the Tax Cap override. Councilwoman Seaman stated we have to have a Public Hearing for that. Supervisor Hyde noted first we have to do the Resolution which I did not bring down. We had the Resolution in the last meeting packet that you all voted down so let me go get it, and we are going to have to.....Are you going to ......Do you guys want to override the Tax Cap or at least hope that we have enough time now to override the Tax Cap or not before I go walking upstairs. Councilwoman Seaman noted you might as walk, and go get it. As long as we have a Preliminary Budget we can think about that.

Supervisor Hyde responded no, no you have to think about it tonight. Do you want.....Do you want to go ahead......Councilwoman Seaman replied that is what I said go up and get it. Supervisor Hyde asked so are you willing to pass it. Councilwoman Seaman replied no we are willing to hold a Public Hearing, and then if we want it passed we have to pass (inaudible). Supervisor Hyde noted we have to pass the Resolution to introduce it. Yes that doesn't mean it passes it means we will have a public hearing. Councilman Needham asked if we could pass it right now. Councilwoman Seaman noted we can't pass it we have to have a Public Hearing on it first. Supervisor Hyde asked how many days notice do you need to do a Public Hearing. The Town Clerk replied I think it is 5 days notice I believe. Supervisor Hyde noted let' see I have to change this date. Councilwoman Seaman noted 5 business days. Supervisor **Hyde** noted today is the 17<sup>th</sup> we should have probably like the 28<sup>th</sup> or 29<sup>th</sup>. **Councilwoman Harris** asked of what. Supervisor Hyde and Councilwoman Seaman responded October. Supervisor Hyde noted we really should adopt a budget before the election because you really absolutely wrong to deliberately wait to adopt the Budget to see who is going to win. That is ridiculous. Councilwoman Ackley asked what does the Law Book say that is what I want to know. I don't care about the election. Supervisor **Hyde** stated it has to be adapted by the 15<sup>th</sup>. **Councilwoman Seaman** stated of November. **Supervisor Hyde** continued noting but **Mrs. Seaman** is making it very clear what she wants to do because she is playing games. It shouldn't matter who wins, who loses the Budget isn't for the person who was elected. It is for the people of this town. It is for to operate the town, and to play games with a budget is a disgrace. It is a disgrace. It is a total disgrace. How about either....You won't be able to put it in tomorrow. The Town Clerk replied I will come in, and put it in in the morning. Supervisor Hyde asked what. The Town Clerk noted I will come in in the morning, and put it in. Supervisor Hyde asked so do you want to have it on one, two, three, four, five. Maybe we should have it on the 28<sup>th</sup> or 29<sup>th</sup> just to be safe. Councilwoman Harris stated the 29<sup>th</sup>. Supervisor Hyde noted the 29<sup>th</sup> is a Tuesday. Councilwoman Harris noted cause the 28<sup>th</sup> is a very special day. Supervisor Hyde noted so do I have a motion......Councilwoman Seaman asked is the 29<sup>th</sup> OK with everybody else. Councilwoman Ackley replied no I have sports that night so if you don't want me to be here go ahead. Councilwoman Seaman noted why don't we do it on the 28<sup>th</sup> then. **Supervisor Hyde** asked you want to do it on the 28<sup>th</sup>. Councilwoman Harris replied I guess, but make sure you bring me a birthday cake. Supervisor Hyde asked the rest of the Board if the 28<sup>th</sup> was good for them. The **Town Clerk** asked what time. 6 o'clock. Supervisor Hyde noted well I am waiting to see if the 28t is good for Brenda. OK the 28th. 6 o'clock or 6:30. 6:30 was agreed upon. Supervisor Hyde noted let me add to this (the Resolution). We are going to hold a Public Hearing, and..... We will do it the same night. Do I have a motion to get a Resolution to introduce a Local Law, and provide notice of Hearings on the floor.
