Dear Ms. Hyde:

I represent The Moeller Family Trust, which owns several parcels of land along the private Bear Pond Extension Road. I write because my clients have learned that the Deer Creek Hunt Club, Inc. wrote to the Town several months ago to request that this private road be opened as a public highway. My clients have asked me to express their opposition to the club's request.

My clients and related family members have owned their properties along the road since 1949, and during this time they never had reason to believe that the dirt road on their property was anything other than a private road. In 2004, the Town confirmed my client's understanding when it corrected its records to show the correct end point of the public portion of the road, and thereafter built a turn-around for the public there. The term 'correction' is apt because the Town had long considered the dirt road across my clients' property to be a private road. Its lack of maintenance after 2004 was no change from its lack of maintenance during the years prior. From 1949 to the present, my clients have spent tens of thousands of dollars of their own money maintaining the dirt road across their property for their personal access and use. This maintenance would never equal what would be considered "town road quality" but the maintenance allowed light access for the family.

Opening Bear Pond Extension as a public road across my clients property would merely provide alternate access for a handful of properties that are already accessed from other roads. No currently inaccessible lands would become accessible if the Town acts on the club's request. McPhillips, Fitzgerald & Cullum L.L.P.

Moreover, the road across my client's property is extremely rugged, steep and rutted in places. Surely, it would not be in the Town taxpayers' interest to spend tens of thousands of dollars to bring this section of private dirt road up to the standards required of public roads, let alone to continue that spending year in and year out.

Therefore, my clients respectfully request that the Town decline to act on the club's request. If you would like to discuss my client's concerns further, please do not hesitate to contact me.

Re: Extension of Bear Pond Road

My property in Thurman includes the south end of Bear Pond and part of the section of road being discussed. The following is the history of the roads around Bear Pond as best we know it:

Prior to 1927, the property on the north side of Bear Pond was accessed by a road along the east side of the pond. In 1927 a dam was constructed to increase the pond which flooded the above access road. Access was then established around the west side of the pond, maintained primarily by the Moeller family with the exception of Town work done in compensation for gravel given to the town for other highway construction (including Drexel Road in 1960).

I don't recall the Town maintaining the road beyond the 405 Bear Pond Road driveway (to house at south end of pond) since 1978. However, the family has always permitted property owners access to their land via the road on the west side of the pond, maintaining the road to a condition we could use without serior damage to our vehicles. I see no reason to change this accommodation for neighboring property owners.

For the benefit of the Town budget, I would suggest total (legal) abandonment of the road past the turnaround at the 405 Bear Pond Road driveway. Access would continue to be provided for neighboring property owners although we would not intend to maintain the road past the gate leading to a logging header. Maintenance there would be done only for logging purposes.

My father kept detailed notes in his ledger books about the property. Attached is a list of items I've found that relate to the road and its maintenance. Please note that August 28, 1978 is the last time that any member of my family has seen any evidence of the town working any part of the old road on the west side of the pond. I'll be happy to provide any other information required to help with the Board's decision.

Please read this letter and attachment at the March board meeting and include it in the minutes.

Copied from notes made by Walter F. Moeller, owner of property around Bear Pond starting in 1927 Submitted by Donald Moeller

<u>April 28, 1951</u> - Discussed with Mr. Hap Osborne, County Supervisor of Highways, purchase of used iron bridge for use to replace bridge at dam. None available. Mr. Osborne recalled request by Monroe some years ago to put road to his cabin in condition which was denied. Osborne said that it was mandatory for Town to abandon any town road that had not been worked for 6 years and hence the Bear Pond-Thurman road should be abandoned. It has not been worked by town since at least 1927 when we acquired Davis property.

<u>June 20, 1960</u> - Gave town several hundred loads of gravel from knolls at Combs place and Bulls place for use in hard surfacing road from Northwoods Inn to Lee Bakers. Town repaired damage done by trucks to our road. Dennis Parker, Road Supervisor

May, 1964 - Town Highway Dept. took fill from gravel pit to repair town road out to Knolls. Repaired damage to our road by their equipment. In payment for gravel, town hauled 5 loads of fill for ramp to barn extension.

May 24, 1967 - part of notes about conversation with Douglass Crockwell of Glens Falls, whose family was interested in the Monroe property beyond Moeller lands:

(Crockwell) Saw road up to Monroes - poses a real problem. Talked with Don Smith about the area - Smith told him town abandoned road some fifty years ago.

Told Crockwell status of our road, built in 1920s and maintained at our expense. Let people having camps up Monroes road use it, principally in hunting season.

<u>Aug. 28, 1978</u> - Town crew scraped and raked road around pond from our corner to gravel pit beyond Bulls place.

12/24/1976 - notes about an old map:
