FISCAL MEETING: The Town Board reviewed all claims.

BOARD MEETING: The regular town board meeting was called to order by **Evelyn Wood, Supervisor.**

Discussion: Discussion ensued regarding resolutions

On a motion by **Councilman Eddy,** seconded by **Councilman Smith,** the minutes of the April 14, 2015 regular meeting were approved.

MOTION CARRIED: 4 AYES ~ WOOD, EDDY, SMITH, SEAMAN

<u>LETTERS</u>: Letters were read from **Candi Cameron** (letter 1) and **Mike Eddy** (letter 2)

Supervisor Wood gave a rebuttal to each letter.

REPORTS:

The supervisor filed the April 30, 2015 treasurers report, operating statement and balance sheets with the town clerk and the following officials gave their verbal reports: Councilman Smith, Councilman Galusha, Councilwoman Seaman, Councilman Eddy and Supervisor Wood.

RESOLUTION # 46: To authorize closing the credit card from Bank of America and to apply for one from Glens Falls National with the credit limit being \$1000.00.

Councilman Smith added that there could not be any fees associated with closing the Bank of America credit card.

On a motion by **Councilwoman Seaman**, seconded by **Councilman Smith**, Resolution # 46 was approved.

RESOLUTION # 47: To amend the wording of resolution # 46 to read that the Thurman Town Board authorizes the closing of the Bank of America credit card provided that there are no fees.

Supervisor Wood said that the board had received a draft of the family medical leave act policy and an updated ethics and disclosure policy to review before the next meeting.

Water Project: Supervisor Wood gave an update on the water project. Three homes impacted by salt have been hauling drinking water and requested a water cooler dispenser.

RESOLUTION # 48: To seek 3 quotes for water cooler/dispensers for three homes with salt impacted water to use only until each home has a RO system that is up and running. On a motion by **Councilman Smith**, seconded by **Councilwoman Seaman**, Resolution #48 was approved.

WHITE SPACE: Supervisor Wood said that a White Space ribbon cutting ceremony had taken place.

Thurman Cemeteries:

Discussion ensued between **Cemetery Superintendent Marc Kenyon** and the town board regarding cemetery regulations. **Mr. Kenyon** said that no major changes had been made but that some regulations had been simplified.

RESOLUTION # 49A: To adopt cemetery regulations.

On a motion by **Councilman Galusha**, seconded by **Councilwoman Seaman**, Resolution # 49A was approved.

PRESENTATION BY PAM MORIN:

First wilderness Corridor promoter **Pam Morin** shared brochures, maps and web site info with the Thurman Town Board. She talked about funding available for special events, advertising in the Adirondack Summer Guide and a guide to ride the train and pass out tourism info. **Ms. Morin** said that there is a possibility that the Lake George Trolley might come to Thurman and she suggested a letter from the Town recognizing it (the trolley coming to Thurman) as a good idea.

RESOLUTION #49B:

A resolution naming two events (Maple Days and the Fall Farm Tour) and agreeing that the TSA be the contractual folks and who would share their financial report

with the first wilderness heritage corridor in order to pursue future funding opportunities, at no cost to the town.

On a motion by **Councilman Galusha**, seconded by **Councilwoman Seaman**, Resolution # 49B was approved.

Resolution Approving Advertisement

WHEREAS, the Thurman Town Board received a request from Laurie Prescott Arnheiter to advertize the town and its events in the Dining and Entertainment Guide, and

WHEREAS the Town has done so in previous years, and

WHEREAS half the cost of the ad will be reimbursed to the town as part of Warren County's First Wilderness Corridor, be it

RESOLVED that the Town Board authorizes a half page ad in the amount of \$645 to be funded by Occupancy tax.

RESOLUTION #54:

AUTHORIZING THE TOWN OF THURMAN TO PARTICIPATE IN THE WARREN COUNTY GOVERNMENT EFFICIENCY PLAN AND SPECIFICALLY IN THE COOPERATIVE PURCHASING PLAN AND ADDING THERETO ANY EFFICIENCY PROJECT(S), SHARED SERVICE(S) OR COOPERATION AGREEMENT(S) SET FORTH IN THIS RESOLUTION AND AUTHORIZING TOWN OF THURMAN OFFICIALS TO TAKE CERTAIN ACTIONS AND MAKE CERTAIN REPRESENTATIONS AND CERTIFICATIONS

WHEREAS, local governments in New York State and specifically in Warren County either singularly, jointly or as part of a County initiative must submit and use best efforts to fully implement a Government Efficiency Plan to be submitted by June 1, 2015 as required by the State Property Tax Freeze Credit to qualify homeowners to receive a property tax credit and

WHEREAS, Warren County has proposed to submit a Government Efficiency Plan on its own behalf as well as on behalf of interested local governments in Warren County and demonstrate required savings on a plan wide basis for all participating local governments beginning in 2017,2018 and 2019 when fully implemented as allowed under the State Property Tax Freeze Plan and

WHEREAS, Warren County's Government Efficiency Plan would include 1) a cooperative purchasing plan as part of a Warren County countywide Government Efficiency Plan which would bid certain commodities on behalf of all participating Warren county local governments with the objective of achieving better pricing and administrative efficiencies; 2) an efficiency initiative by Warren County and 3) efficiency initiatives, shared services and/or cooperation agreements of other local governments participating in the County plan and

WHEREAS, the Town of Thurman desires to participate in the Warren County Government Efficiency Plan and specifically in the cooperative purchasing plan in lieu of submitting its own efficiency plan as allowed under the State Tax Freeze Credit,

NOW THEREFORE BE IT

RESOLVED, that the Town of Thurman shall participate in the Warren County Government Efficiency Plan and specifically in the cooperative purchasing plan and be it further

RESOLVED that the Chief Executive Officer and/or Budget Officer and/or Chief Financial Officer is authorized to 1) analyze and report savings from any efficiency initiatives, shared services and/or

cooperation agreements that the Town of Thurman is undertaking or participating in; 2) represent and/or certify that the Town of Thurman agrees to undertake its best efforts to fully implement the said efficiency initiatives, shared services and/or cooperation agreements as required under the Property Tax Freeze Credit; 3) provide such documentation and other information that may be required by the County for submission of the County Government Efficiency Plan; 4) make all such certifications as may be required by New York State and 5) take any and all such other and further action and execute such documents and certifications that may be necessary or advisable to cause the Town of Thurman to be an eligible and qualified party to the Warren County Government Efficiency Plan and secure the tax credit for residents.

On a motion by **Councilwoman Seaman**, seconded by **Councilman Smith**, Resolution #54 was approved.

MOTION CARRIED: 5 AYES ~ WOOD, GALUSHA, EDDY, SMITH, SEAMAN RESOLUTION #55:

Discussion: Discussion ensued regarding IT services. **Councilman Smith** said that we haven't budgeted for this. **Supervisor Wood** said that we would take it from contingency. **Smith** and **Wood** also talked about looking to shared services for IT support.

AUTHORIZING CONTRACT WITH STOREDTECH FOR IT SERVICES

WHEREAS the town of Thurman has a need for IT services, and

WHEREAS a proposal from Storedtech was received in response to the Town's request for proposals, now therefore be it

RESOLVED that the Town Board authorizes a one year contract with Storedtech to engage them as providers of IT services for the town at a fixed fee of \$1,050/month, which is a yearly cost of \$12,600, and authorizes the Supervisor to sign any necessary documents.

On a motion by **Councilwoman Seaman**, seconded by **Supervisor Wood**, Resolution #55 was approved.

Thurman Board Members,

After the April meeting heated discussion about the town being short of money the taxpayers should be interested in grant funding due Thurman.

Thurman was awarded a state grant through the County to rebuild the River Road Bridge - see attachment.

The Grant applied for was a combination of 3 projects. Thurman - River Road Bridge - \$261,500.00 and Dippikill Road - \$14,562.00. Bolton Landing - Indian Brook Culvert Replacement - \$63,500.00. Total - \$339,062.00

Supervisor Wood has been asked at past board meetings when the money for the bridge would be reimbursed. The reply was - the state and county pay by their own time frame not ours.

See - County Resolution #165 of 2013. The County accepted and amended the budget \$324,500.00, March 15, 2013, 2 years ago. The \$324,500.00 does not included Dippikill - \$14,562.00 If you read further the County Treasurer was to advance the funds on an asneeded basis.

See March 4, 2015 - Economic Growth & Development Committee minutes.

Supervisor Wood updated the committee on the status of the grant award.

Last paragraph:

No administrative funds had been included in the award for the county and/or committee.

For the last 3 years they had been trying to determine what the funds were for (3 years of additional administrative fees)

And the Towns of Bolton and Thurman had been "Very Gracious" about holding onto the expenditures they incurred.

March 4, 2015 the committee graciously agreed to allocate at least half of the funding to the Towns of Bolton and Thurman.

Supervisor Wood obviously knew March 4, the amount that Thurman was going to receive before the March 10 town board meeting and presenting Resolution #26 authorizing the use of the Capital Reserve Funds - Thurman's Savings. She knew at the April 14th meeting.

Why wasn't the rest of the board, highway crew and public informed?

The taxpayers of Thurman will have a choice, by permissive referendum, on whether the Capital Reserve Fund is returned to the General Fund for day to day operations or kept as a Savings for necessary capital improvements and emergencies. Read Resolution #26 March 2015

During the April 14th meeting the public was told Resolution #26 Capital Reserves was for highway expenses and machinery reserve.

The highway budget has been deficient for 4 years.

The 2014 highway budget was \$101,335.68 deficient for paying November and December 2014 bills. It was also deficient in October 2014 by \$49,152.00.

January 13, 2015 town board meeting Resolution #17 was presented and approved. A total of \$115,857.17 was needed to pay 2014 November and December bills. \$14,521.49 was moved within the highway budget accounts. \$101,335.68 was to be transferred from a Road Repair Reserve. The 2014 outstanding bills were paid in January. The Supervisor/Fiscal Officer, stated during April's meeting, "the 2014 bills were paid with 2015 highway budget funds", not as designated by Resolution #17.

At the January meeting the Supervisor informed the public that the Road Repair Reserve included \$145,000.00 Chips - state reimbursement, for paving which is highway account number DA5112.2. The Supervisor, also stated, that if 2015 summer paving was done early enough, money in the budget allocated for state retirement could be used to pay for paving, apply for 2015 CHIPS reimbursement and it might be received back before the state retirement bill was due in December. Listen to the audio of the meeting.

Town Law Manual pg 53 A3 The Supervisor shall: Not permit any fund or appropriations to become overdrawn nor charge one fund or appropriation to pay a claim chargeable to another.

2015 adopted budget, page15 - As of September 30,2014 - Road Repair Reserve balance \$208,993.10

October 2014, Resolution #74 Highway Budget Adjustment - borrowing \$49,152.00 from Road Repair Reserve to be reimbursed by Multi Modal Funds for Bowen Hill Paving Project. At the January meeting it was stated that the money had not been reimbursed to date.

If Road Repair Reserve on September 30, 2014 was \$208,993.10 and \$49,152.00 was deducted in October 2014 the balance would have been \$159,841.10.

In February, Supervisor Wood said it was determined that to move money from the Reserves, the resolution needed to be written differently changing the name of the reserve from Road Repair Reserve to Capital Reserve Fund and a requirement including a permissive referendum.

If it is the same reserve (savings) how did it increase from \$159,841.10 to \$174,024.50 in that short time?

If the Road Repair Reserve was the Capital Reserve Fund - How did it include the \$145,000.00 CHIPS state reimbursement?

Constant contradictions.

"Resolutions are to be specific authorizing particular actions" (Town Law Manual).

Resolution #17 explicitly states the Road Repair Reserve was to be used to pay highway bills. Resolution #17 has not been rescinded.

Town Highway Superintendent manual from Assoc. of Towns, page 15, last paragraph - The town board <u>may not</u> pay from current funds, bills that have accrued from prior years unless those expenses are the result of the emergency or unforeseen circumstances.

It was also stated in April, as scare and threat tactics, that highway employees would be losing their jobs because there would not be enough money in the 2015 highway budget.

The town board, as a group of 5, never discussed or decided line #7 Resolved, that the Thurman Town Board hereby finds that the Fund has more money in it
than the Town is expected to need in the foreseeable future for the purpose it was
established.

Line #13 - Further resolved that the monies currently held in the Fund in excess of such amount shall be returned to the General Fund from which it originated.

Read the December 9, 2014 board meeting minutes page 2 last 5 lines Supervisor Wood - "it's not an option to take money out of the General Fund and put it in the Highway Fund because, #1 you can never get it back and #2 that will blow our budget for next year because we're counting on using fund balance from there to offset our budget. That comment matches the audio recording."

Resolution #26 states nothing about paying 2014 highway bills or reimbursing the 2015 highway budget. Resolution #26 states nothing about creating a highway machinery reserve of \$50,000.00.

Read March 10, 2015 Resolution #26 for yourself.

This is my reasoning for a permissive referendum - let the taxpayers have their say.

Once the Savings are expended it can not be recouped.
