To the Thurman Town Board,

The resolution for the code of ethics and disclosure policy failed during the June 9<sup>th</sup>, 2015 Board meeting. Supervisor Wood brought this before the board. "..... pursuant to General Municipal Law Section 806(1)(a), counties, cities, towns, villages, school districts, and fire districts must adopt a code of ethics which, at a minimum, contains provisions with respect to: disclosure of interest in legislation before a local governing body; holding of investments in conflict with official duties; private employment in conflict with official duties; and future employment."

Some of the disclosures may be a bit intrusive to a private citizen but once in public office it has to be expected that some privacy is lost. This is a given when you hold office and if you object then you should reconsider your priorities.

When asked what specifics in this policy was causing concern, and told that the policy could be adjusted, Councilman Smith mentioned only one item. After some discussion it became apparent that he had completely misunderstood that section. Even with that issue eliminated he still objected to the policy but would state no other specific concerns.

Why?

What parts of the policy are of a concern?

Why not discuss the sections that are of concern?

Why did Councilman Galusha vote nay?

Why did Councilman Smith vote nay?

And why did Councilman Eddy vote nay?

Both Supervisor Wood and Councilman Seaman voted aye.

I'm sure most of you have heard the naysayer's, over the last couple of years, say the "Eddy's" in a derogatory manner.

But the Eddy's have always dealt with facts not rumors.

I would like to address the issue of the letter read by Mrs. Youngblood at the June 9<sup>th</sup> Board Meeting. It's purpose was to bash the Eddy's with character assassination and in particular Michael Eddy a board member.

Loren had a saying passed down from his grandfather, "If one knew better they would do better".
