Supervisor Wood said that American Rock Salt lost the state contract to Cargill whose price reflects a 30% increase. **Wood** said that she would check to see if Cargill has our region and would look into other salt suppliers.

RESOLUTION #53:

Resolution to Override the Tax Levy Limit Established in General Municipal Law 3-c and Adopt Local

Law #1 Of 2013 to Override the Tax Levy Limit

WEHREAS the Town of Thurman must fund increased costs expenses; and

WHEREAS the Town Board held a Public Hearing on the proposed Law to Override the Tax Levy Limit for fiscal year 2014 on November 6, 2013, and

WHEREAS, this resolution is adopted pursuant to subdivision 5 of General Municipal Law§3-c, which expressly authorizes the Town Board to override the tax levy limit by adoption of a Local Law approved by sixty percent (60%) of the Town Board;

NOW THEREFORE BE IT RESOLVED that the Town Board of the Town of Thurman, County of Warren is hereby authorized to adopt a budget for fiscal year 2014 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law § 3-c.

BE IT FURTHER RESOLVED that the Town Board of the Town of Thurman adopts Local Law #1 of 2013 entitled Tax Levy Limit Override for fiscal Year 2014.

On a motion by **Councilman Vasak**, seconded by **Councilwoman Seaman**, Resolution # 53 was approved.

To: Town of Thurman Supervisor & Board Members,

The Town of Thurman Property Tax Collector has been an elected 4 year position to collect the property taxes during January through March.

The current tax collector resigned from the balance of her term.

According to the New York State website there are 562 Town Clerks that are also property tax collectors. It has been proven to work. The town clerks, in the surrounding towns of Thurman, collect the property taxes. These towns are: Bolton, Hague, Horican, Chestertown, Johnsburg, Indian Lake, and Warrensburg.

Please consider the Thurman Town Clerk for this coming year on a trial basis to fill the vacancy for this position, at least until the next election, to see whether it works efficiently.

The Town Clerk's up to date computer would work with the tax collector software. It would not be necessary to purchase an additional computer to be used for only 3 months.

There is not another office space available in the town hall.

The Town Clerk has the hours available that would be convenient for the taxpayers. There are 2 assistances to the town clerk available when needed.

In the past year you have considered Shared Services and consolidation of employees and jobs. This would be a good opportunity to test consolidating the jobs of town clerk and tax collector while maintaining the current classifications and wages for each job respectively.

Attached you will find a list of the calls that WEMS responded to in the Town of Thurman during the month of October 2013. Warrensburg EMS handled two (2) calls in the Town of Thurman and our average response time was 23 minutes. The first call was a priority 2 call (no lights or sirens) but ended up an ALS call. The second call was on River Rd but our crew was given River Street. Only after the crew was on scene in Warrensburg were they notified that the call was for River Road in Thurman. The calls were 911 emergency calls and all calls were at the ALS level. Warrensburg EMS responded to a total of 63 calls in October and 5 of those calls were second out calls.

I know that I mentioned this in my report for last month but it is very important; we have noticed recently in both Warrensburg and Thurman that there are many houses that are not clearly marked with the house numbers. It is very important that all addresses are clearly marked so that the Police, Fire, or EMS responders can easily find you in your time of need.
