ROLL CALL:

Review of claims started at 6:30 pm. The meeting was called to order at 7:00pm.

REPORTS FROM THE BOARD: Supervisor Hyde asked do we have any reports from the Board. Do we have Building and Grounds reports or Landfill reports or....... Councilwoman Seaman noted well while we are talking about Landfill we need to make sure that we hire somebody. The Landfill attendant. Did you take in any applications? Supervisor Hyde asked Susan did we take in any applications for the Landfill. The Town Clerk stated there was no ad to put in, and no applications were (inaudible). Supervisor Hyde noted well we do.....We did have a perfectly reliable um, Landfill Attendant that was fired. I have a Resolution in my meeting packet to hire him back. Councilwoman Seaman noted now can we.....You just stated that we did not......Supervisor Hyde interrupted noting this is not a report. This is reports from the Board that is not that. That is not a report. Do you have a report? Do you have a report Doug? Councilwoman Seaman spoke over the Supervisor noting oh no, no, no let me finish this. Are you finished? Councilman Needham replied no. Councilwoman Seaman continued you just stated Susan that you didn't receive any applications. Correct. The Town Clerk replied I said no ad went into the paper therefore there were no applications turned in. I have not received.....Councilwoman Seaman interrupted noting OK I do know that an application was submitted, and the person came to me and gave me copies just because he knew that that might happen. The Town Clerk responded well I know a person came and got an application from me, but he never returned it. Did you hear me? I know one came and got an application from me, but never returned it, and that was...... Councilwoman Seaman interrupted noting so we do have at least one applicant (inaudible). Councilwoman Seaman stated obviously he did return it. Supervisor Hyde noted and we have like I said we have a Landfill attendant who would very much like to go back to work. Councilwoman Seaman interrupted stating no. We have an application. Supervisor Hyde continued and he has worked for the Landfill for quite a few years. He knows what he is doing, and he would very much like his job back. It was taken away from him because of some made up that um supposedly the Town didn't have any money which was not true. He still hasn't gotten his job back, but would like it back. We do have a Resolution to cover that by the way. Councilwoman Seaman stated the Landfill attendant position was eliminated last June over a year ago. Supervisor Hyde interrupted noting it was.... Was it eliminated? The Town Clerk replied all those positions were defunded. Supervisor Hyde stated it was not, it was defunded. Councilwoman Seaman

stated it was eliminated, and then we put it into the um budget because we thought we could do it again this year. So that requires that applications be accepted. Now I am sure you have applications in your office. Would you like to go into an Executive Session and review them? Supervisor Hyde replied I will not go to my office, and review applications. Councilwoman Seaman interrupted noted well then.....Supervisor Hyde continued the Town Board did not submit.....Councilwoman Seaman interrupted noting then I suggest that we review the application that we do have. Supervisor Hyde continued a Resolution for help wanted ad, and no help wanted ad went in the paper. Councilwoman Seaman stated it should have. Supervisor Hyde continued so you need to understand that no help......That the Town Board did not pass the Resolution to put help wanted ads in the paper. You need to understand that first of all. That is why we do not have any applications. Do you understand? Councilwoman Seaman stated we did. We did pass a Resolution to have a help wanted ad put in the paper. Supervisor Hyde replied Mrs. Seaman I am afraid that is not true. Councilwoman Seaman stated it is reflected in the minutes actually. Supervisor Hyde responded it is not in the minutes. Councilwoman Seaman continued and it was voted on as a matter of fact. Yeah so again you have not placed the ad in the paper. Maybe you would like to try it again to place a help wanted ad. Or we do at least have one previous employee who would like to get the job. Supervisor Hyde stated Mrs. Seaman lets stick to the agenda. If you don't have a report let's go on to privilege of the floor. Let's open privilege of the floor.

PRIVILEGE OF THE FLOOR: Privilege of the floor was opened, and the following residents spoke. Matt Seaman, Jean Coulard, Paula Hubert, Richard Kline, Karma Smith, Barbara Ferrell, Debbie McIllrath, Paula Hubert, John McIllrath, and Joyce Eddy. Privilege of the floor closed at 8:03pm.

DISCUSSION: Councilwoman Seaman noted so Paula had asked the money that was supposedly in account why can't we use that \$6,500.00 to buy new playground equipment. Supervisor Hyde asked why are you asking me. I am not the one that decides.......Councilwoman Seaman interrupted noting well you are the one who said it is the Board so I made a proposal to use the 6,000 that you said was in the account to......Supervisor Hyde interrupted stating well then.....no, no, no. Write your proposal down. Councilwoman Seaman responded I don't have too. Supervisor Hyde noted see what you can get. See what it is going to cost. Councilwoman Seaman noted Resolution. Cynthia. No. I make a proposal.......Supervisor Hyde stated if you want to make a proposal then prepare a proposal, and bring it to the next meeting. Councilwoman Seaman stated I am. I am making...... I am making a motion that we use the \$6,000.00 that the Supervisor has said is in the account. Supervisor Hyde interrupted stating this is not on the agenda. The Town Clerk noted nor is it an emergency. The Supervisor continued this is another instance of Mrs. Seaman is going to blindside everybody with Resolutions that we were not prepared to conduct business on today. The Town Clerk interrupted noting we are not doing it. The Supervisor continued no. I am sorry.......Councilwoman Seaman interrupted noting motions are always accepted from the floor. I made a motion......The Town Clerk stated no. Councilwoman Seaman continued to use the \$6,000.00 that the Supervisor has stated is in the account to be used for the purchase of playground equipment for up there. Supervisor Hyde spoke over her noting go ahead. It is not going to amount to a hill of beans. Councilwoman Seaman asked do I have a second. Councilman Needham stated I will second that. Councilwoman Seaman responded thank you. We have a second. The Town Clerk responded no. Councilwoman Seaman stated yes we do. We have a motion and a second. The Town Clerk stated it is not an emergency. It doesn't need to happen tonight No. There was no public notice. Councilman Needham interrupted with an inaudible comment. Councilwoman

Seaman stated Susan Staples you don't get to decide (inaudible). The Town Clerk responded yes I do. There is no public notice. You were given a memorandum from me about this very subject. Councilwoman Seaman stated may I have the law book please. Or are you going to refuse to give me a copy of the Town Law Manual. The Town Clerk responded I do not have my Law Manual. Where is yours? The Supervisor noted OK let's get on with.......Councilwoman Seaman interrupted noting would you please get it from the town......Your office. The Town Clerk stated we have already addressed this topic in a memorandum. Councilwoman Seaman continued we have a motion on the floor and a second. The Town Clerk continued you are violating open meeting laws by not putting this on the agenda prior to the start of the meeting. It is not an emergency. It does not have to be decided tonight. Councilwoman Seaman spoke over the Clerk noting now we have a motion on the floor and a second, and you were told by the Association of Towns that you have no right to decide what the Town Board can or cannot do. You simply if we take action, you have to record it. That was her words exactly. Supervisor Hyde responded Mrs. Seaman you have to take legal action for her to record it. Councilwoman Seaman stated no I do not. Supervisor Hyde replied she is not here to record garbage. Councilwoman Seaman stated you don't get a choice. Supervisor Hyde noted she is not here to record garbage that is the stuff that gets thrown out, and nobody knows about. Councilwoman Seaman repeated there is a motion on the floor, and a second. There is a motion, and there is a second. Supervisor Hyde asked people to please sit down. Councilwoman Seaman stated so we have the question before us is to use the 6,000 that you said was right in the fund to buy playground equipment at the bands park. All in favor? Councilman Needham asked how much was in there. Councilwoman Seaman responded 6,000 she said. So that is plenty. So we could use up to \$6,000.00. Supervisor Hyde stated I didn't say anything. Just so you know. Councilwoman Seaman stated they won't use it to repair it. They would have to replace it. Councilman Needham stated they would have to replace it. Councilwoman Seaman stated can we have a Roll Call vote please? We....The Board is directing the Clerk to please call the roll. Supervisor Hyde noted excuse me, but you are not the Chairperson of the meeting. Councilwoman Seaman stated I don't have to be. A Board Member......No Board Member has any more power than any other. It is right on the Town website. You posted it. And every Board Member has one vote. So yes we would like.....If you finished with discussion we would like to take a vote. All those in favor? Councilwoman Seaman and Councilman Needham responded aye. Councilwoman Seaman asked all those opposed. Supervisor Hyde acknowledged a resident. Councilwoman Seaman repeated opposed. Opposed. Um apparently the vote......The vote......Supervisor Hyde interrupted noting alright let's get on to the Resolutions at hand. Oh let me.....Let me.....Councilwoman Seaman noted the vote was two in favor. One refused that is a no vote.

The offered Resolution was not properly submitted in writing prior to the start of the meeting therefore it is not part of the official record.

Discussion: So Cynthia does not want the children to have playground equipment, and does not want to use the money for the purposes that it was meant to be used for. Supervisor Hyde noted I would like......I would like to......Councilwoman Seaman stated and that should be......Make sure that that is recorded in the minutes. Supervisor Hyde stated excuse me Mrs. Seaman. Gaveling, she stated I would like to get back to the agenda please. Councilwoman Seaman stated please make sure that that is recorded, Susan. Supervisor Hyde noted what we are going to do next is we are going to do Resolutions, and I would like everybody in this audience to know that I wrote all the Resolutions in this meeting packet, and they were provided to the Board last, I don't mean......Councilwoman Seaman interrupted

noting because you are not in the office (inaudible). Supervisor Hyde continued they were provided to the Board I believe on either Tuesday or Wednesday. So they have had since last week they have a full 7 days to digest what I have proposed to bring up as business at this meeting. That is how it is supposed to be done. Councilwoman Seaman responded no. Supervisor Hyde responded unless it is a dire emergency. Councilwoman Seaman interrupted no that is not what the Law Book says. Supervisor Hyde continued lets remember that, and who is it to protect. Councilwoman Seaman noted that is not the way the law was written. Supervisor Hyde continued this is to protect you so that you don't get blindsided by a Town Board who is not telling you what they are going to do. You want to know what the Town Board is proposing so that you can comment on it if you like....Would wish. Councilwoman Seaman interrupted noting right. Supervisor Hyde noted so anyway do I have a motion to approve a intermuniciapal agreement to the floor.

Discussion: Supervisor Hyde noted the agreement is very large. I did email the Town Board a good week ago, and asked them if they would like to read it that they should please contact the **Town Clerk**, and come in and read it because I have no intention of making copes of something this large, and um so if the Board has any discussion on this or are we ready to vote? **Councilwoman Seaman** noted no this is standard. I mean as far as I am concerned. **Supervisor Hyde** noted OK Roll Call.

A Roll Call Vote was called.

RESOLUTION TO APPROVE AGREEMENT

The town board of Town of Thurman approves the agreement between County of Warren, Warren-Hamilton Counties Office for the aging and the Town of Thurman for transportation of the elderly. **Discussion:** Supervisor Hyde noted this is the senior bus that goes around on Friday. I think it is once a month, and they pick up seniors and they take them to Walmart, and they take them shopping down at Glens Falls. We have been doing this....We have done it for years and years. Any discussion on that? Roll Call please.

A Roll Call Vote was called.

Motion Carried: Ayes~3 Needham, Seaman, Hyde, Nays~0

Discussion: Supervisor Hyde asked OK now I have a.....Do I have a motion to get a Resolution to adopt the Town of Thurman Sexual Harassment Policy? Do I have a motion? For those in the audience the sexual harassment policy for all employers in New York State is an absolute.....There is really......I don't know why the State insist that we have a Resolution because we have to do this. I have brought this to the Board oh this is.....The Town Clerk noted third time. Supervisor Hyde continued I think this is the third time, and I cannot get the Board to instate a Sexual Harassment policy. We have had to take education. Everybody that works in the Town Hall has had to watch a video. Actually anybody that works anywhere in the state apparently has to do this. So I don't have a motion to get this on the floor? Councilwoman Seaman responded nope the State wants (inaudible). Supervisor Hyde noted alright well I guess we once again I will try next month. Councilwoman Seaman stated well the problem is who you report to as far as I am concerned, and we don't have (inaudible). Supervisor Hyde stated Gail I did not write it, the State did. OK. New York State wrote this Mrs. Seaman, and I am sorry that you don't agree with it. Councilwoman Seaman interrupted stating actually yes you did. Yup that is OK. You won't pass the Ethics law either. Supervisor Hyde asked do I have a motion to get a Resolution on the floor to reinstate the Transfer Station Attendant? Councilwoman Seaman stated you can't reinstate a position that was eliminated. Supervisor Hyde asked can I get.....Have a motion to get a Resolution on the floor to reinstate the Transfer Station Attendant that was let go. That was asked to not work because of defunding that was not necessary. OK no motion we won't get.......Councilwoman Seaman stated no I'll make a motion to advertise for a Landfill attendant......Supervisor Hyde interrupted noting no sorry Mrs. Seaman, but that was not.....You did not provide that to the Town Board or the public. We have.......I'm sorry Mrs. Seaman as she gaveled. Councilwoman Seaman continued speaking over the Supervisor noting yeah actually we have. Yeah. We need to......Supervisor Hyde stated I am sorry Mrs. Seaman, but I'm on Resolutions right now. I am asking you to be quiet so we can continue. Do I have a motion to approve....... Councilwoman Seaman spoke over the Supervisor noting we need to get a motion on the floor to hire the following positions. A Town maintenance person, landfill attendant and cemetery worker. Supervisor Hyde noted Mrs. Seaman I am trying to (inaudible) cemetery worker. Councilwoman Seaman stated yeah, and that is why I am making a motion to advertise again for the post. Supervisor Hyde gaveled and stated Mrs. Seaman, Mrs. Seaman you are out of order Mrs. Seaman. Councilwoman Seaman asked do I have a second? Supervisor Hyde again noted Mrs. Seaman you are out of order. Councilman Needham seconded. Councilwoman Seaman stated I have a second. We have a motion. No, I am not. We have a motion and a second. We have a motion, and a second to advertise for the position of Town Maintenance Person, Landfill attendant and cemetery worker. On the website, in the PostStar and the Sun. Supervisor Hyde gaveled and said you are out of order Mrs. Seaman. You are out of order. Councilman Needham asked didn't we already pass that? Councilwoman Seaman replied yeah we already passed it, but they are not doing it. This was all passed at a meeting (inaudible). Councilman Needham stated one more time. Councilwoman Seaman noted one more time. Supervisor Hyde gaveled again noting Mrs. Seaman you are out of order Mrs. Seaman. We are on

Resolutions that were provided to the Board and the public. We are not on those Resolutions. Those were not provided to the public. Councilwoman Seaman stated we made a.....We have made a motion. And it is on the floor, and a second. Supervisor Hyde noted you are out of order. Councilwoman Seaman stated no, I am not. Supervisor Hyde noted yes you are Mrs. Seaman we are doing the Resolutions from the meeting packet. Councilwoman Seaman stated show me the law that says I am out of order. Show me the law. Supervisor Hyde asked do I have a motion to get a Resolution to approve a contract with the Thurman Connection Snowmobile Club. Councilwoman Seaman spoke over the Supervisor noting no, we have a motion on the floor and a second. She continued we have a motion on the floor and a second. Supervisor Hyde noted please, please no comments from the floor. Have you seen any of these Resolutions form Mrs. Seamanz? The Town Clerk replied no. Supervisor Hyde stated neither have I. The Town Clerk noted and you know they will not be entertained. Supervisor Hyde stated we are not have privilege of the floor right now. Councilwoman Seaman stated we have a motion on the floor. The Town Clerk stated they are violating open meeting law. They know it, and they know they won't be entertained. Supervisor Hyde stated you are violating Town Law and Open Meeting Law. Councilwoman Seaman replied show me the law. That is all I ask. Show it. Show it to me. Because according to the Town Law Book a Board Member can make a motion at any time. Supervisor Hyde spoke over her noting we will just sit here wait until she gets through her violation then we will move on. There is nothing else we can do. Councilwoman Seaman asked so are we going to discuss getting this? So do you want to advertise because we are in the discussion phase now. We have a motion and a second. Supervisor Hyde responded Mrs. Seaman no, I do not want to discuss something that was not provided to the public or any other Board Members. Councilwoman Seaman noted so Town Supervisor refuses to discuss a motion made by a Town Board person legally at the meeting to post the following positions and advertise for Town Maintenance person, a Landfill Attendant and a Cemetery worker on the Town website and in the PostStar. This has also been already been voted on, and the motion carried by three yeas with Ackley, Needham and Seaman, and that was on the 16th of July (Clerk's note that was an illegal meeting with no public notice. Any action taken at that meeting is not official). Supervisor Hyde asked can we get on with the Resolutions now please? Councilwoman Seaman stated so since we have a motion and a second I say we call the vote if you don't want to discuss it. Supervisor Hyde stated you are not the Chair of the meeting. Councilwoman Seaman interrupted stating I don't have to be. Supervisor Hyde stated if you guys want to vote go vote. Get your vote over so we can please continue with our meeting. Councilwoman Seaman asked all in favor? Councilman Needham responded aye. Councilwoman Seaman stated aye. All opposed? I guess the Supervisor doesn't want to hire for the positions. OK. Let the record show that no vote is a no vote.

The offered Resolution was not properly submitted in writing prior to the start of the meeting therefor it is not part of the official record.

Discussion: Supervisor Hyde stated it wasn't a Resolution. Councilwoman Seaman stated yes it was. It was a motion actually. Supervisor Hyde noted it wasn't a Resolution to vote on that is why I didn't vote. OK. Councilwoman Seaman stated yup it was (inaudible). Supervisor Hyde continued OK do I have a motion to get......We are skipping over this like we actually got to it. Do I have a motion to get a Resolution on the floor to approve the Contract with the Thurman Connection Snowmobile Club? Do I have a motion to get that on the floor so we can give the Thurman Connection Snowmobile Club the \$27,000.00 that they really would like to have? Councilwoman Seaman stated we already did that five times, and you have ignored it every time so I don't think it matters. Supervisor Hyde stated so

apparently we are not going to get that business conducted because we can't get a motion or a second. So lets.......Do I have a motion to get a Resolution to approve additional duties um, on the floor. Councilwoman Seaman replied no, you just said you didn't want to hire for those duties. Supervisor Hyde noted OK, I guess we are not going to get that done. This was a Resolution to hire somebody to do light maintenance, weed, mow and weedwack the cemetery, but I guess the Town Board isn't interested in doing that. OK, now I have......I have the Resolution to approve the claims. We have the General.....Do I have a motion to get the (inaudible) on the floor. Councilwoman Seaman stated first we need to discuss something because you won't discuss it beforehand. Supervisor Hyde responded no, no. You have to get a motion on the floor before we discuss. Councilwoman Seaman replied no, we need to......Supervisor Hyde asked are you discussing the claims. Councilwoman Seaman answered two claims yes. Supervisor Hyde stated then you need to make a motion. Make a motion to get it onto the floor. Until a motion is made we are not......Do youIf somebody makes a motion to get the Resolution to pay the claims on the floor......Councilwoman Seaman asked Cynthia what claims are you.....What motion......What claims are you paying? From what number to what number, and what do they add up to? Supervisor Hyde stated excuse me I am asking for.....OK forget it they don't want to make a motion to get the darn Resolution on the floor. Councilwoman Seaman replied you have to tell us what the motion is. Supervisor Hyde responded to get a Resolution to pay the claims on the floor. The claims. All the claims. The General Fund claims, the Enterprise Fund claims, the Highway Fund claims. The same claims that we......Councilwoman Seaman asked how much. How much in each because (inaudible) you have here. Supervisor Hyde noted I am asking for a motion to get this on the floor. That is how we conduct a meeting. Do I have a motion to get the Resolution to pay the claims. Councilman Needham interrupted stating yes. Councilwoman Seaman noted yes you have it, and I will second it.

Now can you answer a couple of questions? What claims are you paying? Or do you think you are paying? **Supervisor Hyde** noted the claims that are on the Abstract that you were provided that are unpaid as of tonight. **Councilwoman Seaman** stated oh well you see there is a problem with that. **Supervisor Hyde** asked what is that problem **Mrs. Seaman? Councilwoman Seaman** noted I need to know what the number is. From what number to what number. **Supervisor Hyde** noted **Mrs. Seaman** you have the entire......You have all the bills, and the Abstract. I don't know what you talking about. It is all there. You just spent an half an hour looking at (inaudible). **Councilwoman Seaman** stated voucher numbers. It is not difficult. It is not a difficult concept. **Supervisor Hyde** stated then you do it.

Councilwoman Seaman responded you have to identify the voucher numbers. Supervisor Hyde noted Mrs. Seaman......Councilwoman Seaman interrupted noting well before we do anything we have to now discuss these. Supervisor Hyde noted ah huh. Councilwoman Seaman responded yeah. Supervisor Hyde stated so go ahead and discuss. Councilwoman Seaman stated we asked you the last time when we approved them going to that that this person was also employed by another municipality, and the Town of Thurman only pays for half of it. Supervisor Hyde noted well she is not going to that training for the other town. She is going to that training because she is the Court Clerk in Thurman, and that is why she needs......She has to have that training Mrs. Seaman......Councilwoman Seaman interrupted noting and she has to have the training for the other town.....Supervisor Hyde continued so I strongly advise that you approve those two vouchers because this very necessary to our Court. And why you would question that is.....I....That is what we have in front of us. Councilwoman Seaman noted because the Court Clerk is a Court Clerk in another municipality. So it would be required for that municipality also. So the Town of Thurman only pays half the bill. The other municipality pays the other half. The Town Clerk stated I believe the other municipality pays for other training, and this is an even trade off. Councilwoman Seaman stated no. Nobody has that in writing anywhere, and I want to see what they pay for then because that is not the way you are supposed to do it. They pay half of it. We pay half. Supervisor Hyde noted first of all the mileage has nothing to do with the training and that......Councilwoman Seaman noted yes it does. Because its.....It's all the cost. Supervisor Hyde noted this miles......Oh yeah it is after the fact. Councilwoman Seaman noted yeah it is. Supervisor Hyde replied well I'm sorry but you need to pay those claims. Councilwoman Seaman stated well until you.....Until....No, until you get that figured out as to what the other municipality pays pull those two out. Supervisor Hyde asked why don't you call the other municipality.....Councilwoman Seaman interrupted stating it is not my job. You are the Chief Financial Officer. Supervisor Hyde responded I am sorry if you have a question you do the homework. I don't do your homework. You need to do your homework Mrs. Seaman. Councilwoman Seaman responded this is your job. Supervisor Hyde stated Mrs. Seaman. No Mrs. Seaman my job isn't to do homework for Mrs. Seaman. Councilwoman Seaman asked are you the Chief Financial Officer? Are you..... Cynthia are you the Chief Financial Officer? Supervisor Hyde replied my job isn't to do homework for Mrs. Seaman. Mrs. Seaman needs to do her own homework. That is why you are on the Board. Councilwoman Seaman asked Cynthia are you the Chief Financial Officer? Supervisor Hyde continued noting sorry Mrs. Seaman I don't do your homework. Councilwoman Seaman continued stating which you do get paid extra for being the Chief Financial Officer. Supervisor Hyde asked so what are we doing with the claims? Are we paying our bills this time or not? Councilwoman Seaman stated pull them out. I said pull them out. Supervisor Hyde stated I do not want to pull them out. We owe that money to that person. Supervisor Hyde continued come in here during the day before the gosh darn Board Meeting......Councilwoman Seaman interrupted stating already told you this. Over a month ago. Supervisor Hyde continued so if you have a question you have a couple of days to ask that question, but when you.....Councilwoman Seaman interrupted stating let me see your exact response was that we don't have to do this. We have to do this at the next Board Meeting when they submit a bill. Because I asked this question um before we approved the training. Supervisor Hyde stated I am not going to agree

(inaudible) because it is not right. Councilwoman Seaman noted that is right I know because you don't look at stuff. Supervisor Hyde noted this is.....The Court Clerk should not have to pay for the gas to go to a training that she had to have in order to work for the Thurman Town Court. That is really rotten to even suggest. Councilwoman Seaman spoke over the Supervisor noting so what is the number? And she has......And she has to have it for the other Town Court. She continues No, I absolutely want to pay for it, but half of it. Supervisor Hyde noted Mrs. Seaman if that was one of your friends you would never do that. That is the problem here. Councilwoman Seaman stated Cynthia friends has nothing to do with it. This is town, taxpayer money. Supervisor Hyde stated you pick and choose how you......You do not do an overall everybody get treated the same. You pick and choose. Councilwoman Seaman stated I am sorry, but I stand up for the Taxpayers. Supervisor Hyde replied no you don't Mrs. Seaman. OK so Mrs. Seaman changed this whole Resolution around. Councilwoman Seaman noted what you didn't say anything. Supervisor Hyde asked all those in favor? Councilman Needham asked in favor of what? Councilwoman Seaman stated no, no. The purpose of this Memorandum is to clear up some misconceptions in reference to statements which have apparently been made at a recent Town Board meeting and in a subsequent email.

First, we understand that, at a recent Town Board meeting, a Town Board Member told the Town Board and public in attendance that I told the Association of Towns not to speak with Town Board Members. You may be absolutely assured that I have neither made any such statement or request of the Association of Towns in reference to any officials of the Town of Thurman or any of the numerous other municipalities we represent, nor would I ever do so.

Second, a Town Board Member referred to me in an email on July 25th and stated that "he doesn't like to be on the record". We are mystified by this statement simply because I am in fact "on the record" on literally dozens if not hundreds of occasions throughout any year if for no other reason than the simple fact that I represent more municipalities and attend more municipal Board meetings than any other local attorney. Nonetheless, there are certainly occasions when my colleagues and I refuse to be quoted by media representatives, especially in reference to matters of litigation. However, it is abundantly clear that I have no reservation about being "on the record" when appropriate, including but not limited to in the Town of Thurman.

As the first statement was made at a regular Town Board meeting, we respectfully request that this Memorandum be read aloud at a public meeting and entered into the public Record. It does not bear any attorney/client privileged stamp or legend and it should not be treated as such. Thank you.

Dear Town Board Member Seaman.

This email is in response to your inquiry regarding the procedure to schedule a town board meeting.

There are three ways to schedule a special town board meeting. First, the town board itself may schedule a special town board meeting by board resolution - this resolution must be adopted by a majority vote while at a board meeting (Town Law, §63). A majority vote of a five member board would be three, with each board member, including the supervisor, having one vote (Town Law, §63). Please note that your town board's own rules of procedure may have additional requirements (Town Law, §63). Second, the supervisor may schedule a special town board meeting on his or her own initiative (Town Law, §62). Third, the supervisor must schedule a special town board meetings upon the written request of two or more town board members; in this case the special meeting must be called within 10 days of receipt of said request. (Town Law, §62). Notice in all three circumstances must be provided in accordance with section 104 of the Open Meetings Law. Notice must also be provided to the town board in accordance with Town Law, §62 where the special meeting is called by the supervisor. Written notice to town board members under Town Law, §62 must be provided to each board member at least two days in advance of the meeting. Notice to the press and the public under section 104 of the Open Meetings Law must be provided at least 72 hours before the special meeting if the meeting is scheduled a week or more advance or to the extent practicable if the meeting is scheduled less than a week in advance. Notice to the public is provided by posting it on the town clerk's sign board and the town website and notice is provided to the press in whatever means the town has determined.
