ROLL CALL:

Review of Claims started at 6:30pm. The meeting was called to order at 7:00pm.

REPORTS FROM THE BOARD:

Discussion: Councilwoman Seaman noted just for the fact that I know you have a Resolution in here, but Pat has said that he now with everything going on this summer needs a replacement. He needs the Town to hire somebody for up at the Landfill as a part time that we have budgeted, and we need to have that put out to bid. Actually we need to have it posted as a job opening. Supervisor Hyde stated excuse me, but the only reason there is not a second Transfer Station Attendant is because the Town Board defunded that position for no rational reason, and that is the only reason we don't have a person in there. There was a person at the Landfill as a Landfill attendant for the last couple of years, and his......He was never fired his position was defunded. So there is a Resolution with that information in there to rehire Mr. Smith. That is the Resolution. Why don't we talk about that then. Councilwoman Seaman noted Cynthia the Resolution you are talking about can't be done because......Supervisor Hyde interrupted noting why don't we wait until we get to the Resolutions to discuss that. Councilwoman Seaman continued why don't we discuss this right now for the fact that it has been one year that position was eliminated. Eliminated by Resolution. Supervisor Hyde stated it was not eliminated. It was not eliminated it was defunded. Councilwoman Seaman continued and it has not been filled. Are you going to let me finish? Supervisor Hyde replied it wasn't You need to give accurate information Mrs. Seaman. Councilwoman Seaman interrupted noting I am. Supervisor Hyde replied then prove it. It was not eliminated. Councilwoman Seaman noted read the Resolution it says it was eliminated. Supervisor Hyde replied it was not eliminated. Councilwoman Seaman noted it has not been.....Supervisor Hyde interrupted noting get your facts straight before you bring them out to the public please. Councilwoman Seaman asked are you finished now? Good. It was eliminated, and it has not been filled for the first six months of 2019, and as such it need to be posted as a job opening. A job opportunity. So that.....Because there have been a lot of people that have been asking for it in the community. Supervisor Hyde asked then why wasn't the first Landfill attendant posted? Councilwoman Seaman interrupted asking did you want us......Supervisor Hyde continued the first Landfill attendant position was not posted. It was given to Ed Brown. Who was an employee of the Town who retired, and who

requested to work at the Landfill. The Board did not ask for letters of interest in that instance. So why now are we going to make a different rule for the second Landfill attendant? When that position was filled by someone. That person was never fired. There was no reason to fire that person. It was defunded for a reason that made no sense and that is the only reason we don't have a Transfer Station attendant. Councilwoman Seaman noted Cynthia, Ed Brown was working in the position as a member of the Highway Department. Would you rather we fire him? Supervisor Hyde noted no he was not. Councilwoman Seaman replied yes he was. He was being paid from.....Supervisor Hyde interrupted noting he was only a fill in. Councilwoman Seaman replied he was being paid by the Highway Department Supervisor Hyde interrupted noting but he was....No......Don't put words......Councilwoman Seaman continued for his job at the Transfer on every Saturday and Wednesday and Sunday, and you would have us fire him in order to post a job. Supervisor Hyde replied please don't put words in my mouth Mrs. Seaman. Councilwoman Seaman spoke over her noting so that we don't have a perfect.....Well that is what you are saying you want to do. Supervisor Hyde noted Mr. Brown was a fill in when somebody was absent. And he did a good job, and he knew what he was doing. And so we retained him when he went from the Highway to the Transfer Station. Councilwoman Seaman interrupted noting so you retained him in that position. That is correct. Supervisor Hyde continued Mr. Smith was also doing a good job, and he was not fired. Mrs. Seaman you have different rules for different people......Councilwoman Seaman spoke over her noting you are correct. Retained him. No it is the same. Supervisor Hyde continued depending on whether or not you like them or not. I think that is quite clear to everybody. Councilwoman Seaman interrupted noting you retained Mr. Brown. Supervisor Hyde continued so the Board will have to decide on this. If the Board wants to ask for letters of interest when we have a perfectly good candidate who was never fired then we can waste a whole bunch of time, and not..... and Pat will have to keep his person at the Transfer Station at least a whole other month, and maybe more. And so since the need is here and now it would make sense to put Ernie back up there since he is already qualified and trained and knows what he is doing. Councilwoman Seaman noted Cynthia would you like (inaudible as Councilwoman Ackley spoke). Councilwoman Ackley asked so Pat requested this? I am asking (inaudible). Supervisor Hyde replied yes, he doesn't want his person up there (inaudible as Councilwoman Seaman spoke over her). Councilwoman Seaman interrupted noting Pat, Pat, Pat wants another person he did not request the same person that was there. He just said that we needed to advertise to hire someone. Supervisor Hyde noted he didn't make any comments any (inaudible as Councilwoman Seaman spoke over her). Councilwoman Seaman interrupted noting yes, he did because I talked to him. He requested that we advertise to hire someone. He did tell me that there were several people who approached him in town that would like the position. It is a very physical position, and we want to make sure that the person who gets the position can handle the duties of the.....Perform the duties of their job. There is a lot of heavy lifting there. Supervisor Hyde replied Mr. Smith was quite capable, and had worked at the Transfer Station for several years. Councilwoman Seaman noted I didn't say he wasn't. Supervisor Hyde continued up until the point that the Town Board defunded his position along with several others for no good reason. Councilwoman Seaman noted would you like to go to Executive Session to discuss this. Supervisor Hyde replied no. Councilwoman Seaman continued between the Board. Because you shouldn't be discussing personnel issues in front of anybody else. Supervisor Hyde noted you brought it up Mrs. Seaman. Councilwoman Seaman replied no, I brought it up that we need to advertise for the position. Supervisor Hyde replied Mrs. Seaman you brought it...... If you didn't want to discuss it in public you shouldn't have brought it up. Let's go to privilege of the floor. Councilwoman Seaman interrupted

noting we need to advertise for that position. **Supervisor Hyde** noted we are not talking......We will do Resolutions when Resolutions.....When the time comes for Resolutions.

DISCUSSION: Councilwoman Seaman noted I have a Resolution that I would like to bring back to the floor that was done......Supervisor Hyde interrupted noting excuse me Gail. Councilwoman Seaman continued a couple of weeks ago, and this is a Resolution that the Town Board has passed one already to have the septic system certified by the Town Engineers. Supervisor Hyde interrupted noting Mrs. Seaman wait a minute. Are you telling me.....Mrs. Seaman......Councilwoman Seaman interrupted noting to bring this Resolution back to the Board. Do I have......I would like to make a motion......Supervisor Hyde interrupted noting you are being a bull (inaudible) this table. Councilwoman Seaman continued to bring this Resolution to the floor. Do I have a second? Councilman Needham replied I will second it. Councilwoman Seaman stated I have a second. Now we can discuss it. Supervisor Hyde noted I have (Councilwoman Seaman spoke over the Supervisor)a statement for the minutes. Councilwoman Seaman interrupted noting this is my Resolution. Supervisor Hyde continued to make her statement noting but I think we all notice that I was sitting here since about 6:30, and this is the first that I have been told that there is a Resolution. This Resolution was not shared again with the public or with any other Board......At least not me. I did not see this Resolution. So once again we have Mrs. Seaman bringing surprise Resolutions to blindside the Board. Councilwoman Seaman spoke over the Supervisor as she spoke noting you have seen it three times Cynthia. You have seen it. You have seen it three times. She continued this Resolution was brought to the Board in May. Actually I think it was brought in April. And it says.

Whereas the Town attorneys work for the entire Town Board not one single member and

Whereas the Town Supervisor has stated she will not follow the legally adopted Resolutions because the Town Attorneys have non-specified questions regarding the Resolution

Therefore be it resolved that the Town Board directs that a copy of Resolution #27, and a copy of the letter with the cost estimates from Cedarwood Engineering dated February 1, 2019 along with this

Resolution be forwarded to the Town Attorneys Miller, Mannix, Schachner and Hafner by the Town Clerk no later than the end of business Friday June 28⁻ 2019 and

Be it further resolved that the Town Attorneys are directed to write a Resolution for the Town Board accepting the Town Engineer's proposal including the specific timelines and progress updates to be presented to the Board as noted in Resolution #27 to be reviewed and discussed at the July Regular Meeting and

Be it further resolved that the source of funding will be identified as coming from the Contingency Account expense code 19904.1 and

Be it further resolved that if any questions arise regarding this Resolution that said questions be emailed to all Board Members to seek accurate interpretation. If necessary a Special Meeting can be requested and

Be it further resolved if the Town Attorneys find anything in this Resolution questionable it will be considered that all parts will be in full force and followed until addressed separately at a Regular Board Meeting and

Be it further resolved because accurate information is not forwarded to the Town Board in a timely manner the Town Attorneys are directed that from this day forward all correspondence between the Town Supervisor and the Town of Thurman, and the town attorneys Miller, Mannix, Schachner and Hafner whether by email, U.S. mail, Fax or phone (summary of that) will be emailed to each individual Board Member at the same time which is sent or received by any party. The Town Clerk will supply all email addresses to the town attorneys with this Resolution and

Be it further resolved because the Town Supervisor has refused to follow adopted Board Resolutions the town attorneys are directed to explain in writing to the Town Supervisor her duties regarding following adopted Board Resolutions, and the consequences of her repeated refusal to follow such Resolutions. A copy of which to be forwarded to each Board Member.

when are you people going to understand that there's rules. And the rules are there to protect the public, and you people just totally ignore them. And think it is funny Mr. Needham. You are not funny Mr. Needham. Councilwoman Seaman asked Cynthia are you finished insulting people? Supervisor Hyde noted it is not funny Mr. Needham. Councilman Needham responded rules. Your rules are funny. Your rules are funny. You make them up as you (inaudible). Supervisor Hyde responded I do not make up rules. You three made a bunch of rules then smiled and laugh about it. How disgusting. Councilwoman Ackley stated you do the same thing. You sit here and smirk all the time so don't even. The whole entire time. Councilman Needham stated let's vote on it. Supervisor Hyde stated this is abuse and harassment. This is I repeat abuse and harassment. Councilwoman Seaman asked can we have a roll call please? Councilwoman Ackley noted it is not as bad as you standing up calling out letters in front of people. Supervisor Hyde replied this is abuse and harassment Brenda. All three of you should be ashamed of yourselves. And they sit here, and they laugh. Councilwoman Seaman asked (inaudible) make a roll call please. Supervisor Hyde noted there are a lot of people not laughing. Excuse me......Councilwoman Seaman noted the Town Clerk can make the Roll Call. Supervisor Hyde stated I still have not seen the Resolution. The Town Clerk noted I don't have the Resolution either. Councilwoman Seaman stated you received a copy of it. Supervisor Hyde noted I have not received a copy of any Resolution that you have proposed to bring to the floor. Councilwoman Seaman interrupted noting here you go. That is a copy. Supervisor Hyde continued the Resolution full of harassment and abuse about me. Full of things that you have no right to ask anybody to do. Councilwoman Seaman stated yeah we do. Supervisor Hyde stated you can go ahead and pass it, but I am going to tell you the same thing is going to happen. Councilwoman Seaman stated let's see what the Town attorney says. Supervisor Hyde continued it is going to go the way of many of the Resolutions that you three have passed that in the end are not viable Resolutions, and cannot be followed. My guess is since I haven't had a chance to read it, but from what I heard I would say this sounds like another one of those kinds of Resolutions that I won't be able to follow. And I will be accused of not following. When in truth I can't follow it so that is my warning. Councilwoman Seaman spoke over the Supervisor noting yup. You wouldn't understand it anyway. Right. You know.....You know what the good thing is you don't have to do anything because the Town Clerk has been directed. She has to send it to the attorneys so we know it will get there. Supervisor Hyde replied well I would certainly advise that this Resolution not be passed. Councilwoman Seaman replied good, you have a vote too. Supervisor Hyde noted it makes no sense.....Councilwoman Seaman spoke over the Supervisor noting can we vote? Can we....Can we please call the vote? Supervisor Hyde continued and Resolutions are for business. They are not for harassment and abuse of other Town Board Members or the Supervisor. They are not for abusive......Councilwoman Seaman interrupted noting don't be nasty. Supervisor Hyde continued they are not to include abusive language against the Supervisor, and that is what so many of these Resolutions include. Correct Susan. Councilwoman Seaman interrupted noting can we.....Can you please call the rules....The vote. Would like to call the roll please Town Clerk.

Discussion: Supervisor Hyde asked do you have any other surprise Resolutions **Mrs. Seaman? Councilwoman Seaman** stated no, only that we need to go over that contract that you just had done at the expense of the Town. **Supervisor Hyde** noted alright I would like to start with Resolutions since **Mrs. Seaman** so rudely just interrupted, and injected her last minute blindsiding Resolution. Now let's get on

with what was on the agenda, and has been on the agenda since oh, several days before June 12th. All these Resolutions were provided to the Board ahead of time, and provided to the public, and it is the proper way to do things. I do not blindside the Board as much as **Mrs. Seaman** does. **Councilwoman Seaman** spoke over her noting no you never did. **Supervisor Hyde** continued so I would like to get a motion to get a Resolution to approve a contract with the Thurman Connection Snowmobile Club on the floor. Do I have a motion?

RESOLUTION TO APPROVE CONTRACT WITH THURMAN CONNECTION

SNOWMOBILE CLUB

The town board of the Town of Thurman approves the contract with the Thurman Connection Snowmobile club and authorizes the supervisor to sign the necessary paperwork.

Discussion: Councilwoman Seaman noted I will second it so that we can discuss it. Supervisor Hyde noted I would like to...... I had the attorney write up a contract.... Councilwoman Seaman interrupted noting it is not a good one. Supervisor Hyde continued to enter into with the Thurman Connection Snowmobile Club. In the past the Town.....There is money that the Town receives from the County in the amount of \$27,000.00, and in the past we would get sent the check, and then once we had the money we would pass it on the Snowmobile Club. We would deposit it in the bank account. We would write them a check. Well this year they decided to change it a little bit, and they are asking us to front the Snowmobile Club \$27,000.00. And so we have to take that out of our operating money and, then once we give the check to the Snowmobile Club, and they cash it. Then I get a picture of it back from the bank. Then I take that picture, and I send it to the Treasurer, and then the Treasurer will then send me a check to cover. So because we are fronting \$27,000.00 of Town money I spoke with the Attorney, and he recommended that the Town and the Snowmobile Club have a contract. The Town and Warren County have a contract. Warren County passes that money along to the Town and that is in the contract, but I felt and the Attorney felt it was necessary to have a contract with the Snowmobile Club and the Town. So I had the Attorney write that up, and that is what this Resolution is about. Councilwoman Seaman replied good now can we discuss it. Good. OK. Supervisor Hyde noted the Board was provided with the contract several weeks ago so they have had several weeks to read it. Councilwoman Seaman noted OK now are you finished. Can we discuss it? Supervisor Hyde stated I need that contract back because I have something to add to it. Councilwoman Seaman asked OK now are you finished? (Inaudible) to discuss it? Supervisor Hyde stated I need that contract back because I have something that I need to add to it. Councilwoman Seaman replied well you can't because this is my copy that I have written on. Supervisor Hyde responded excuse me give me.....The Town Clerk noted she took your copy. Supervisor Hyde stated give me that, that is my copy because you got it.....I need that.....I need to......Councilwoman Seaman responded well I am sorry. Supervisor Hyde continued noting give me my copy of the contract. I need to read something Mrs. Seaman. Councilwoman Seaman noted Cynthia. Supervisor Hyde continued noting give me the contract I need to read something out of it. Councilwoman Seaman replied well maybe after. Supervisor Hyde repeated give me the contract Mrs. Seaman I need to read something out of it. Councilman Needham interrupted asking where is my copy of the contract. I don't have a copy of it. Councilwoman Seaman noted I asked for copies, and she

refused to print them. Supervisor Hyde responded you were given....I emailed you a copy of that contract weeks ago. Councilwoman Seaman repeated asked for copies, and she refused to print them. Supervisor Hyde responded I am sorry Mrs. Seaman has no problem printing her Resolutions. I am sure she can print a contract. Councilwoman Seaman responded Cynthia. Supervisor Hyde stated I need a copy of that. I need that so I can read it. Councilwoman Seaman responded I am sorry I asked you to print copies, and you refused. I told you I needed this copy. Supervisor Hyde asked you are refusing to give me that copy so that I can read it. Councilwoman Seaman replied yup. The Town Clerk noted call the police. Call the police. It is not your copy. Councilwoman Seaman stated it is my copy I told you that. Supervisor Hyde stated it is not your copy. It was my copy that I printed for myself. Councilwoman Seaman noted OK are you through (inaudible) now. Supervisor Hyde noted you people were provided a copy of that weeks ago. Councilwoman Seaman interrupted noting no we were not. We were provided with an email which is not a copy. Alright now while we are going through this I notice that A the Board never asked......Supervisor Hyde and Councilwoman Seaman both noted please don't speak from the floor. Councilwoman Seaman continued the Board was never asked if we needed another contract with the Snowmobile Club because we didn't give you any permission to go to the Attorney to spend money on a contract that obviously is not correct, and should be......Things need to be taken out of it. Secondly last year you gave the Snowmobile Club their \$27,000.00 without even an agreement in place. You just handed them a check, and said go for it. So I'm not sure why now we have to have.....We already passed two or three Resolutions that said we have an agreement with the Snowmobile Club, and to pay them the money, and you refuse to pay it. Supervisor Hyde stated we don't have an agreement with the Snowmobile Club we have an agreement with the County. We have no agreement with the Snowmobile Club. Councilwoman Seaman asked then what is this. Supervisor Hyde noted that is the agreement between the Town and the Snowmobile Club that I am trying to pass. To cover.....To protect the Town......Councilwoman Seaman interrupted noting because I asked......I'd like. Councilman Needham noted where is the agreement with the County? We haven't seen that. Councilwoman Seaman noted we haven't one with the County. Councilman Needham noted we haven't seen one in twenty years. Councilwoman Seaman stated because in all honesty......Supervisor Hyde interrupted noting this.....What. You never saw an agreement between the Town and the County? Councilman Needham noted not with the County. No. Supervisor Hyde noted that is so funny because you voted on it. Was that not correct? I think it was in March. I brought the agreement between the County and the Town. And I brought a Resolution, and then you people gave me permission. Councilwoman Seaman interrupted stating to get the money for the Snowmobile, and we......Supervisor Hyde continued you abstained at that one. I am sorry that you don't remember that you approved a contract between the County and Town. Councilwoman Seaman interrupted noting Cynthia why don't we.....Why don't we try to stay on topic. Supervisor Hyde noted maybe you need to try to (inaudible) those things because you are part of the Snowmobile Club. Councilwoman Seaman interrupted noting alright Cynthia why don't we try to stay on topic because it is going to be hard. Supervisor Hyde continued please don't accuse me of things that are not true Mr. Needham. Councilwoman Seaman noted OK in this contract that she wants to make a third party that has been taking care...... The Thurman Snowmobile Club has been taking care of the trails for I don't know how many years, and the County has a contract with them. Now my guess is that the County probably required proof of a check that the Snowmobile Club actually got their money to make sure that they actually get their money. Well this agreement says that the Town has undertaken, and may or may not sponsor a third party or third parties through contracts or maintenance for the promotion of a Snowmobile Club. I first I propose that on that third paragraph it

says whereas the Town has undertaken, and is willing to undertake and sponsor with the Thurman Snowmobile Connect Club for the development, maintenance and promotion of the snowmobile trails within the Town used by all Warren County residences. And in the next paragraph, the fourth one, it says whereas the County of Warren has agreed to pay the Town during the Fiscal Year 2019 the sum not to exceed \$27,000.00. The Town shall in turn use said Funds for maintenance and promotion of the trail system by the Thurman Snowmobile Club for the promotion.....For the snowmobile trail development, maintenance and for promotion. And then the big one because this would be a.... A factor that really bothered me. I can't imagine it wouldn't bother the club. Number 5 it says this agreement shall be for the term of one year commencing January 1, 2019, and terminating December 31, 2019. It then goes on to say, and I.....I would prefer that all of it to be expunged because you have to remember that this is not Town money being used. It is County money that they are paying the Town. As soon as we prove that we have given it to the Snowmobile Club, but they want the Club to sign a contract that says the Town of Thurman reserves the right to terminate this agreement at any time upon the failure of the Thurman Connection Snowmobile Club to satisfactorily render services required under this agreement, and to expend the monies in accordance with the terms and provisions of this agreement. In the event of such termination all the monies paid to the Thurman Snowmobile Club by the Town and not expended according to this agreement shall be repaid to the Town upon demand. This is not Town money. This is Warren County money given to the Snowmobile Club for the promotion of the Snowmobile trails, and as such would never go back to the Town. By the way this also happens to be a pet peeve I'm sure of Cynthia's because this wasn't an issue last year. Now it is an issue. Probably because all of her trying and brow beating and talking bad about Doug to try to get him to resign hasn't worked. This is trying to control the......Supervisor Hyde interrupted stating you are harassing me right now with your verbal abuse. Verbal abuse. Councilwoman Seaman noted are you going to let me finish? This is a simple attempt at trying to hold something over their head that the Town can just for any reason decide that they are going to terminate an agreement. The agreement with the Town basically ends the minute the club gets that check, and no attorney for a club is going to let them sign something like that. I propose that we take everything out of that after the one year term because you still......Now every other club has gotten their money from the County. Thurman is the only Town that has not given the Club their money. Does anybody have any problems with taking out those pieces for the Club? Brenda do you? Do you (to Councilman Needham)? Supervisor Hyde replied well I certainly trust the Town Attorney more than I trust Mrs.Last I knew Mrs. Seaman doesn't have a law degree. Councilwoman Seaman responded the Board is the one that decides what we sign, and what we don't sign. Supervisor Hyde replied that is fine with me. If these three Board Members don't want to protect the Town let (inaudible) the Town it's money. I would think that the Snowmobile Club would......I don't.....I'm sure that they plan on doing what they are supposed to do with that money so why would they be threatened by that? You would only be threatened by that if you.....If you thought maybe you weren't, but I am sure that they plan on doing what they are supposed to with the money so why would that even be a problem as long as they do what they are supposed to do. Councilwoman Seaman interrupted noting no. When we have passed so many (inaudible). She continued because the last person I took their word that they were going to do something we aren't getting it. They said it is too bad you didn't have it written in a contract. That was last......That was a week and a half ago. Supervisor Hyde remarked here we are harassing someone again. Councilwoman Seaman replied no so I will never trust somebody that says don't worry we will take care of it we don't need it written in a contract. Supervisor Hyde noted Mrs. Seaman you don't need to degrade people that come to these

meetings.....Councilwoman Seaman interrupted noting I didn't. Supervisor Hyde continued with your nasty remarks. Councilwoman Seaman continued that's just the facts. That is what was said. Supervisor **Hyde** responded it wasn't. It is not the facts. What comes out of your mouth are not facts. Councilwoman Seaman interrupted noting that is exactly what was said. They are on video if you would like to see them. Councilwoman Seaman continued to make changes to the contract. Supervisor Hyde noted so I would like to let everybody know that Mrs. Seaman is rewriting the contract that was written by the Attorney. Just so that everybody is aware of what she is doing. Councilwoman Seaman responded I am not rewriting it. Just taking out what the Board feels necessary. Supervisor Hyde interrupted noting rewriting the contract that was written by an attorney. Councilwoman Seaman replied are you going to be......You know what I am going to say that we are going to hold off on passing this because obviously the Town Clerk doesn't want to do her job, and....The Town Clerk replied my job....Supervisor Hyde interrupted noting excuse me we can do without the comments from the floor, and we can do without your constant verbal abuse against people at these meetings Mrs. Seaman. Councilwoman Seaman

interrupted noting oh. She continued well if you......Supervisor Hyde continued noting verbal abuse Mrs. Seaman you verbally abuse people verbally people at every single Town Board Meeting. It is disgusting Mrs. Seaman. Councilwoman Seaman spoke over the Supervisor noting well if you.... Cynthia you are the one who is screaming. This is the one screaming. Yes you are. Supervisor Hyde continues you are a disgusting excuse for a Board Member with your abusive behavior Councilwoman Seaman spoke over the Supervisor stating absolutely. Yup. OK now we can put these away or we can do it the hard way. It is up to you. I am asking for copies again. I would like 5 copies. One for each of us, and one for you. Would you like to please make copies of this? Supervisor Hyde stated it is up to the Clerk. She can do it if she wants, but you cannot make demands of her. Councilwoman Seaman replied actually OK the role of the Town Clerk. Councilwoman Seaman replied I didn't have it prior to the start. I asked her and she said no. So now you are refusing to give a Board Member copies. OK we'll read it. Supervisor Hyde noted Mrs. Seaman you......Councilwoman Seaman interrupted stating if you keep your mouth shut. Whereas the County of Warren has agreed to pay to the Town during the fiscal year 2019 a sum not to exceed \$27,000.00 and the Town shall in turn use said funds for maintenance and promotion of trail system by the Thurman Snowmobile Club Incorporated. The Thurman Connection Snowmobile Club Incorporated. For snowmobile trail development and maintenance and or promotion of and

Whereas the Town Board of the Town of Thurman approved this agreement with the Town of Thurman and Thurman Connection Snowmobile Club incorporated on the 24th day of June 2019. Now therefore it is mutually agreed upon by and between the parties as follows

The Town hereby agrees to sponsor or cause and encourage the continuation of the development, maintenance or the promotion of snowmobile trails within the town.

Two: Any resident residing in Warren County shall be permitted access to the Town's sponsored or controlled snowmobile trails at the same charges which apply to the Town. Three: The Town of Thurman agrees to pay the snowmobile, the Thurman Connection Snowmobile Club Incorporated during the fiscal year 2019 a sum not to exceed \$27,000.00. The Thurman Snowmobile Club Incorporated shall in turn use said funds for the purposes of equipment, trail development, and or promotion of the trail systems similar to that which existed in previous years.

Four: The Thurman Connection Snowmobile Club shall indemnify and hold the Town of Thurman and it's officers, agents and employees harmless from any claims, notices of claims, demands, causes of actions and judgments arising out of injury to persons including death or property whatever kind or nature as a result of furnishing the services provided in this agreement in connection with the development, maintenance and or promotion of said snowmobile trails referred to in this agreement and or purchase and use of equipment as provided for herein. And shall name Warren County and the Town of Thurman as additional name of insurers on the any insurance policy to provide coverage of liability assumed hereunder with the exception of workers compensation.

Five: This agreement shall be for a term of one year commencing January 1, 2019 and terminating December 31, 2019.

Six: This agreement shall be deemed executory only to the extent of money made available to the Town through its annual appropriations for this agreement, and no liability on account thereof shall be incurred by the Town beyond monies appropriated therefore.



Section 2-16. Town Board

B. Responsibilities. The town board is the executive and legislative branch of town government.

1. Majority of board acts as body. The town board, as a group, is the executive head of the town and must function as a body. Thus, an individual board member or supervisor may not unilaterally act on behalf of the town board and each town board member has the same authority as any other board member. In most instances, a simple majority (3 votes) is necessary for the board to take action.

promise to pay any political assessment, subscription or contribution. Every officer or employee who may have charge or control in any building, office or room occupied for any governmental purpose is hereby authorized to prohibit the entry of any person, and he shall not knowingly permit any person to enter the same for the purpose of making, collecting, receiving or giving notice therein, of any political assessment, subscription or contribution; and no person shall enter or remain in any such office, building or room, or send or direct any letter or other writing thereto, for the purpose of giving notice of, demanding or collecting a political assessment; nor shall any person therein give notice of, demand, collect or receive any such assessment, subscription or contribution. No person shall prepare or take any part in preparing any political assessment, subscription or contribution with the intent that the same shall be sent or presented to or collected of any officer or employee subject to the provisions of this chapter, and no person shall knowingly send or present any political assessment, subscription or contribution to or request its payment of any said officer or employee. Any person violating any provision of this subdivision shall be guilty of a misdemeanor.

4. Prohibition against promise of influence. Any person, who while holding any public office, or in nomination for, or while seeking a nomination or appointment for any public office, shall corruptly use or promise to use, whether directly or indirectly. any official authority or influence, whether then possessed or merely anticipated, in the way of conferring upon any person, or in order to secure or aid any person in securing any office or public employment, or any nomination, confirmation, promotion or increase of salary, upon the consideration that the vote or political influence or action of the last-named person, or any other, shall be given or used in behalf of any candidate, officer or party, or upon any other corrupt condition or consideration, shall be deemed guilty of bribery or an attempt at bribery. Any public officer, or any person having or claiming to have any authority or influence for or affecting the nomination, public employment, confirmation, promotion, removal, or increase or decrease of salary of any public officer, who shall corruptly use, or promise, or threaten to use any such authority or influence, directly or indirectly in order to coerce or persuade the vote or political action of any citizen or the removal, discharge or promotion of any officer or public employee, or upon any other corrupt consideration, shall also be guilty of bribery or of an attempt at bribery. Every person found guilty of such bribery, or an attempt to commit the same, as aforesaid, shall, upon conviction thereof, be liable to be punished by a fine of not less than one hundred dollars nor more than three thousand dollars, or to imprisonment for not less than ten days nor more than two years, or to both such fine and imprisonment in the discretion of the court.

CIVIL SERVICE LAW

 $\S 107$. Prohibition against certain political activities; improper influence.

- 1. Recommendations based on political affiliations. No recommendation or question under the authority of this chapter shall relate to the political opinions or affiliations of any person whatever; and no appointment or selection to or removal from an office or employment within the scope of this chapter or the rules established thereunder, shall be in any manner affected or influenced by such opinions or affiliations. No person in the civil service of the state or of any civil division thereof is for that reason under any obligation to contribute to any political fund or to render any political service, and no person shall be removed or otherwise prejudiced for refusing so to do. No person in the said civil service shall discharge or promote or reduce, or in any manner change the official rank or compensation of any other person in said service, or promise or threaten so to do, for giving or withholding or neglecting to make any contribution of money or service or any other valuable thing for any political purpose. No person in said service shall use his official authority or influences to coerce the political action of any person or body or to interfere with any election.
- 2. Inquiry concerning political affiliations. No person shall directly or indirectly ask, indicate or transmit orally or in writing the political affiliations of any employee in the civil service of the state or of any civil division thereof or of any person dependent upon or related to such an employee, as a test of fitness for holding office. A violation of this subdivision shall be deemed a misdemeanor and conviction thereof shall subject the person convicted to a fine of not less than one hundred dollars nor more than five hundred dollars or to imprisonment for not less than thirty days nor more than six months, or to both such fine and imprisonment. Nothing herein contained shall be construed to prevent or prohibit inquiry concerning the activities, affiliation or membership of any applicant or employee in any group or organization which advocates that the government of the United States or of any state or of any political subdivision thereof should be overturned by force, violence or any unlawful means.
- **3. Political assessments.** No officer or employee of the state or any civil division thereof shall, directly or indirectly, use his authority or official influence to compel or induce any other officer or employee of the state or any civil division thereof, to pay or
