Review of claims started at 6:30 pm. The meeting was called to order at 7:00 pm.

PLEDGE OF ALLEGIANCE TO THE FLAG.

ROLL CALL:

MOMENT OF SILENCE: A moment of silence was observed for Barbara Keene. Supervisor Hyde stated Barbara was someone who was active in Town for a long time. She was a journalist for a time. Her husband was a judge for a long time, and I believe he also served on the Town Board. Back then the judge automatically served on the Town Board if I remember correctly. She noted she would be missed by many she was sure. Joyce Eddy noted that Barbara was a phone caller for the fire company.

A moment of silence was also observed for the victims of 911.

Discussion: Supervisor Hyde noted I have prepared packet today on this. I would like to read some of it. We.....We have to appoint a Sole Appointed Assessor. Back in 2016 the Town Board passed a Local Law going from 3 elected to Sole Appointed. The Sole Appointed Elected.....The Sole Appointed Assessor's term is 6 years. In this particular case our Sole Appointed Assessor was elected for the first 3 years of that term. So there was 3 years left of that term. All towns across the State of New York have to appoint an Assessor this year because the term runs out September 30th, and the new term starts September 1st. $\textbf{Councilwoman Seaman} \ \text{noted October} \ \textbf{1}^{\text{st}}. \ \textbf{Supervisor Hyde} \ \text{continued the term for Sole Appointed}$ Assessor is 6 years. OK. We ha.....We'll start with the first page. We have....I'll read it. The term for Sole Appointed Assessor is 6 years. All Towns in New York State will reappoint or appoint a Sole Appointed Assessor this year. The Thurman Town Board has received two letters of interest in the Sole Appointed Assessor position. One Mr. Tuck Birdsall is seeking reappointment to a position that he has held for 20 plus years. His salary for the last three years has been \$11,000.00 per year. He keeps office hours at least 3 days per week. Plus spends many hours out in the field looking at property. Our second applicant is Mr. Christian Holt currently the Town of Johnsburg Assessor. He is seeking to work 1 day per week in Thurman for \$20,000.00 a year. I would like to note that Mr. Holt was.....Is no.....As of the end of this month is no longer the Johnsburg Assessor. He did apply, but he was not reappointed. OK the next page....I would like to just read what an Assessor does because I really think a lot of people really don't understand what the Assessor's job is. This is from the New York State Office of Finance and Taxation. Can everybody here me? OK. Who is the Assessor, and what does the Assessor do? And I gave a link to this website so you can read it if you want to at another time. Who is the Assessor? The Assessor is a

Local Government official who estimates the value of Real Property within a city, town or village boundary. This value is converted into an assessment which is one component in the computation of Real Property Tax Bills. What does an Assessor do? The Assessor is obligated by New York State Law to maintain assessments at a uniform percentage of market value each year. The Assessor signs an oath to this effect when certifying the Tentative Assessment Roll. The document containing each properties assessment. The physical description or inventory, and value estimate of every parcel is required to keep.....To be kept current. In order to maintain a uniform roll each year your Assessor will need to analyze all of the properties in the municipality to determine which assessments need to be changed. Where assessments need to be changed in some cases your Assessor will be able to increase or decrease the assessment of a neighborhood or a group of properties by applying real estate market trends towards a property. This is possible only when the assessments to be changed are at a uniform level other than a municipalities stated level of assessment. In other cases the Assessor will need to conduct physical reinspections for reappraisals of property. Every assessing unit should be keeping all assessments at a fair and uniform level every year. The Assessment Roll shows assessments and appropriate exemptions. Every year the Roll with preliminary or tentative assessments is made available for public inspection. After the Board of Assessment Review has acted on Assessment complaints, and ordering any changes, the Tentative Assessment Roll is made final. I would like to put a note there that the final Roll is public information. Every last word in it. What kind of property is assessed? All Real Property commonly known as real estate is assessed. Real property is defined as land, and any permanent structure which is attached to it. Some examples of Real Property are houses, gas stations, office buildings, vacant land, motels, shopping centers, saleable natural resources, oil, gas, timber, farm, apartment buildings, factories, restaurants and in most cases mobile homes. OK, next page. Why is it important......I wrote this part. Why.....Excuse me Mrs. Seaman, but I am reading to the audience could you please be quiet. I would appreciate that. Councilwoman Seaman asked do you need that much attention. Supervisor Hyde continued why is it important to keep assessments current? Why should the Assessor visit properties to see if improvements have been made, and then measure those improvements. Keeping assessments current creates equity for the Town. Sales tax is a major revenue for a town. The county collects sales tax, and keeps half. The other half of the sales tax is split between the towns in that county. How much a town gets of that sales tax is determined by the total assessed value of the town. So if the Assessor doesn't keep the assessments current, and the value of the town goes down or stays stagnant the town gets less money. If the Assessor does his job well, and increases the value of a town the town gets more money. The less a town gets in sales tax revenue the more the town has to raise in taxes. To meet the General Fund appropriations in our town sales tax is 76% of that revenue to meet those appropriations. Property tax is 10. We surely wouldn't like the property tax to be more now would we? And the other revenue sources are 14%. A reason to keep assessments current is.....Another reason to keep assessments current is fairness. If a landowner makes an improvement on his land, and the Assessor doesn't assess it then that landowner is not paying their fair share of the tax burden which in turns places a heavier burden on those landowners who are assessed properly. How would you feel if you paid taxes on your house that you built years ago, but the guy next door didn't because the Assessor didn't bother to get out, and assess his home that was built last year? Well, that is exactly what happens if an Assessor doesn't visit properties. We have two applicants like I said. Um, I would like to point out their years of experience. Tuck Birdsall has been our Assessor for 20 years. He has done an excellent job. He has....He gets out, and he goes around town. He makes sure that he keeps all the property.....The properties current. Christian Holt is the other applicant, and he has been the

Assessor in Johnsburg for 6 years. I got a hold of Warren County, and they sent me a spread sheet to show the total assessed value of the two towns, and the changes. If you look at the two you can see the good job our Assessor has done every year since 2014 our assessments......Our total assessed value of our Town has increased, and there is a reason for that. Because our Assessor gets out and does what he needs to do. Sometimes people get mad at him for that, but what he is really doing is his job. If you look at the other applicant you can see that there were small increases in 2015, and 16. In 2017, 2018 and 2019 the Town of Johnsburg lost value, and um that was very concerning to the Johnsburg Town Board. Councilwoman Seaman noted did you also bother to tell them that they were in the midst of a revaluation? This year. Supervisor Hyde responded they are not in the midst of a revalve. Councilwoman Seaman interrupted noting yes they are. Supervisor Hyde stated they are not in the midst of doing a revalve. They are about to do a revalve. I also would like.....Councilwoman Seaman interrupted noting now you also should......You also (inaudible). Supervisor Hyde continued noting excuse me I am not done. I would also like to read a letter..... I would also like to read a letter fromThat was read at the last meeting, and I would like to read it because two of our Board Members were not present. This is from the Stoney Creek Assessor. Councilwoman Seaman interrupted stating oh no we are not going to read that again. Geesh. Supervisor Hyde continued reading the attached letter. During the reading of the letter she noted that the report was attached to the letter. Councilwoman Seaman interrupted asking did you want to.....Cynthia can I stop you for a second please. Cynthia. Cynthia I need to interject a word in here. Cynthia. Supervisor Hyde responded I am reading something here. Councilwoman Seaman replied no you're not, but I just want to make sure that people have the um, the knowledge that yes this gentleman wrote this letter for you, but even Stoney Creeks Assessor does not......Even Stoney Creek's Assessor......I can't finish a thought. Cynthia. Even Stoney Creeks Assessor does not use this form that Tuck uses so just to make sure that people know. Supervisor Hyde was gaveling the Councilwoman and stating you are out of order Mrs. Seaman. Councilwoman Seaman stated you are out of order. Supervisor Hyde stated you are out of order. Councilwoman Harris noted he is not saying one or the other here. Supervisor Hyde stated let me finish. Councilwoman Seaman stated he doesn't use the same assessment methodology as our Assessor. Supervisor Hyde finished reading the letter. Supervisor Hyde stated and I just think it is important to note that this isn't me saying this, or Joan saying this, or Brenda saying this or Doug saying this. This is New York State that is saying that we do an excellent job. That our Assessor in the Town of Thurman does an excellent job. Now I would like to open priv......Excuse me did you have something to say? Councilwoman Seaman stated yes I do. Now while we are on this you said it was really important that all the assessments get turned in, and that you visit everything on time so that all the assessments are correct. Right? Tuck? Supervisor Hyde replied excuse me, but he doesn't have to.....Let us hear what you have to say. Councilwoman Seaman stated I'm just......I'm just concerned that there is somebody right here that I had looked up that Tuck has been asked to go over their assessment several times. They have just moved into a new house last Christmas. But boy their Star exemption, and everything is on their old house still, and their new house that they have been living in for 9 months is only assessed at 50% done. Um that was listed on June 2019 that you submitted it. So they are getting the more expensive Star exemption off of the house that they are not even living in. Supervisor Hyde noted I would like to comment before you do Tuck. Councilwoman Seaman stated oh no, no names have been (inaudible), and I am not finished. We also have um a problem with.....I know a lot of people have been hit with waterfront property. A lot of people have argued about waterfront property. Tuck you yourself own waterfront property on Glen Athol Road, and it is not assessed at all. Because it is all covered under......It is covered under wetlands

which make it exempt. Mr.Birdsall replied that is incorrect. It is assessed. Councilwoman Seaman interrupted asking it is? Mr. Birdsall continued taxes are paid on it, and wetlands are not exempt. It is assessed at a lower rate. Councilwoman Seaman stated is assessed at a lower rate. Why? Why? Supervisor Hyde noted Mr. Birdsall I happen to have the Assessment Rolls behind us. Councilwoman Seaman spoke over the Supervisor noting oh because yeah I know (inaudible). That is OK. Because when Mrs. Seaman makes an accusation we have the Tax Roll behind us. Would you like to......If she is going to do this we have the Assessment Roll. Councilwoman Seaman noted so I just I just asked you. Mr. Birdsall responded this is not the place to go over cherry picking individual assessments. Councilwoman Seaman interrupted stating I am not cherry picking. Mr. Birdsall continued noting you can come into my office anytime. Councilwoman Seaman interrupted stating oh no, no. That is not the (inaudible). Mr. Birdsall noted because you have never been in there. Councilwoman Seaman interrupted stating yes, Tuck I have. Mr. Birdsall continued noting it is right down, right down the hall here. Councilwoman Seaman stated yeah Tuck I have. Mr. Birdsall replied you have never step foot in there. Councilwoman Seaman responded obviously I have. Oh you weren't there last time. Supervisor Hyde gaveled noting Mrs. Seaman that is enough. You are being a nasty.....You are being nasty to Mr. Birdsall. Councilwoman Seaman replied Cynthia button it. Listen I.....Supervisor Hyde stated Mrs. Seaman you cannot back up one single thing that you have said. Councilwoman Seaman stated I just did. The Assessment Roll filed with the State. With Warren County. Now......Councilwoman Harris stated if you want to discuss something with **Tuck** you should come in another day in the office. Supervisor Hyde noted we are not here to put people down. Although that is what she is doing. Councilwoman Seaman stated oh no that is what you have been doing. Um now just another question. I was told probably erroneously, but somebody told me that you handed in your resignation. Did you? Mr. Birdsall stated that's incorrect. No. That is incorrect. Councilwoman Seaman responded you didn't hand it in. OK, so the person that told me was incorrect. OK just wondering because they told me......When did you hand in your letter of interest and proposal to the Town Clerk? Mr. Birdsall responded well I handed one in at the original meeting. Councilwoman Seaman interrupted asking what original meeting? Mr. Birdsall replied that first time you were going to discuss the Sole Assessor. The Town Clerk noted prior to the July meeting. Councilwoman Seaman asked did you hand in a letter of interest and a proposal? Councilwoman Harris noted Tucker July ninth holding up his envelope. 2019 she continued. Councilwoman Seaman replied wait a minute that is not.....Alright I am just asking......Supervisor Hyde noted Mrs. Seaman, Mrs. Seaman you are being very rude, and inappropriate, and out of order. Councilwoman Seaman replied I am sorry I am allowed to ask questions. Supervisor Hyde stated that is not why we are here for you to ask questions. Councilwoman Seaman continued so when did you......When did you, and where was your proposal because we didn't see any proposal from you. Supervisor Hyde stated Mrs. Seaman we got a letter of interest. Councilwoman Seaman stated and there is no resume. Supervisor Hyde noted Mr. Birdsall it is OK because Mrs. Seaman has been trying to.....Trying to spread all around town that Mr. Birdsall did not submit a letter, and because of that I had to contact the Town Attorney. Councilwoman Seaman interrupted stating you had too. No, no, no you see......Supervisor Hyde continued I sent the Town Attorney.......Councilwoman Seaman stated the Town Attorney means nothing unless he is sitting here, and answers our questions. Councilwoman Harris noted she was given the letter the same time I was, and so was Doug, and they (inaudible). Supervisor Hyde stated let me read the memorandum. Councilwoman Harris noted they did not take the letter with them. Supervisor Hyde read we have reviewed the Town Board Resolution authorizing solicitation of letter of interest for those wishing to be

appointed Assessor. Councilwoman Seaman interrupted stating yup. Supervisor Hyde continued we have also reviewed the solicitation itself which was published. The Resolution required the solicitation ad to state only that all applicants must meet New York State requirements for the position, and to please submit letters of interest, qualifications and proposals.....Councilwoman Seaman interrupted stating proposals. Supervisor Hyde continued reading to the Thurman Town Board for consideration. Councilwoman Seaman interrupted stating no proposal. Supervisor Hyde continued reading however, it appears that the Resolution did not specify that the solicitation had to list any certain requirements of the interest letter. Likewise the ad was published as directed, and the solicitation did not contain any specific requirements nor did it have too. Under these circumstances the Town Board is free to consider any letters of interest which are submitted from anyone. None are legally excluded from consideration for failure to include any certain information as again no specific information was required. We hope this clears up any confusion about this issue. Thank you. That is from the Town Attorney. Councilwoman Seaman interrupted noting he said.....So, so I guess.......That refuses to come and be asked, and be addressed by the Town Board. Now just out of couriousity the Board did state we wanted letters of proposal with this. A letter of interest, and a letter of proposal because you see for the last couple of years all we heard is somebody is being underpaid, and it is terrible, and he shouldn't have to work like this. And that is what a proposal if for. To know exactly how much he wants for the job. Is required for where that money is going to go, and if we should consider it, but I guess it is OK to have another 6 years of having everybody angry because Cynthia and Joan, and the other Board agreed with Mr. Birdsall for \$11,000.00 a year, and now you blame the rest of the Board who had nothing to do with those. So that is what the proposal was for. I have received no proposal. All I have is your continuing Education which is from 2000 which is great, but there is no um.....There is no resume. There is no proposal of what you plan to do in the office or (inaudible) do. Or what your salary requirements might be. Mr. Birdsall replied I assumed that this would be the time when we would discuss it. Not here, but after the appointment. Councilwoman Seaman stated no you don't discuss something after the appointment **Tuck.** You discuss it before that is why we know. **Supervisor Hyde** noted **Mrs. Seaman** now first of all. Let me clear this up. First of all this year we have this year's budget. We have a line for Assessor. We have the money appropriated for that line. That is all we have for the rest of this year appropriated for the Assessor what is left of the Assessor.....What is left at the end of this month. We wont talk about what we are going to pay the Assessor for next year until budget time. Councilwoman Seaman interrupted noting it is budget time now. Supervisor Hyde continued once the Assessor is appointed which is.....Which would mean that he starts the new term in October he will be required to submit a budget estimate or we will submit a budget estimate for him. Well in the case of our Assessor we had a budget estimate for him, and it is.....The Assessor can't demand what he wants, and we can't sit here and say oh because you proposed \$20,000.00 or \$11,000.00 we are going to pay that to you because we haven't done our budget yet for 2019 so we are even discussing yet what we are going to pay somebody next year. Councilwoman Seaman spoke over the Supervisor stating it is due the 29th of this month so I suggest you hurry up. Supervisor Hyde stated that is not up for discussion at this time. Councilwoman Seaman continued noting that is actually what a proposal, and anybody applying for a job gives the people so that you can budget correctly what the salary requirements are. Only after we know. I take it you go out and buy a car and don't ask what the price is. You just sign your name and then figure you are going to dicker with them afterwards. Councilwoman Harris noted I take it that you go to a job and say you are going to pay me first (inaudible) before you even.....Councilwoman Seaman interrupted noting when I go for a job I do. I submit my salary requirements. Absolutely. Supervisor Hyde stated we

all know what......We all know what Mr. Birdsall has worked for for what his salary has been for the last three years. Councilwoman Seaman spoke over her noting the point of it is.....And you have complained about it for two years. Supervisor Hyde continued there is no reason why he had to propose what his salary is going to be. Councilwoman Seaman interrupted stating of course he does. Supervisor Hyde noted I just read the memorandum. I am sorry but you are wrong. What you are saying has no substance at all, and you are wasting our time with this nonsense. Councilwoman Seaman spoke over her noting no I am right. She continued noting because the Board passed a Resolution. No. The Board passed a Resolution asking for proposals. We got no proposals. Supervisor Hyde noted Mrs. Seaman are you telling me that the lawyer doesn't tell the truth. Councilwoman Seaman noted the lawyer didn't answer that question did he? You didn't tell him to come and talk to us. Supervisor Hyde responded this is our Town Attorney. Mrs. Seaman I am sorry, but you are not correct. Councilwoman Seaman stated well I have asked for three months to have the attorney here to ask questions. Letters of interest, qualifications and proposals. Yes it does you are right. Supervisor Hyde noted we would like to get on with privilege of the floor. Councilwoman Seaman stated well this memorandum does say that the Town Board for consideration that applicants must meet requirements, and to please submit letters of interest, qualifications and proposals to the Town of Thurman Town Board for consideration. OK the Resolution did specify that we wanted letters of interest and proposals. Only got one. Supervisor Hyde stated let's get on with privilege of the floor. Councilwoman Harris stated we got two. Councilwoman Seaman remarked no, there is not another proposal. If you can show me another proposal I want to see

So in order to grant their request we would have to call a public hearing to adopt a Town Regulation which would have to give the public 5 day notice of the hearing. We would have to post legal ads in the paper, and we would have to have the public hearing. And then we could adopt the Regulation. Councilman Needham asked when do they want to do this. Supervisor Hyde noted October 5th and 6th. Councilman Needham noted we don't have the time to do it. Supervisor Hyde noted we

We have reviewed the Town Board Resolution authorizing solicitation of letters of interest from those wishing to be appointed Assessor. We have also reviewed the solicitation itself which was published.

The Resolution required the solicitation ad to state only that all applicants must meet NYS requirements for the position and to "please submit letters of interest, qualifications and proposals to the Thurman town board for consideration." However, it appears that the Resolution did not specify that the solicitation had to list any certain requirements of the interest letters. Likewise, the ad was published as directed and the solicitation did not contain any specific requirements (nor did it have to).

Under these circumstances, the Town Board is free to consider any letters of interest which are submitted from anyone. None are legally excluded from consideration for failure to include any certain information as, again, no specific information was required.

We hope this clears up any confusion about this issue. Thank you.

Dear Supervisor and Town Board Members:

I saw with the legal notices that you were advertising for a new Appointed Assessor. This letter is a commentary on the assessment in the Town of Thurman that I hope you will use as a guide in your deliberations on appointing a new or current assessor to fill this vital office.

This letter, really a study of assessment quality in the Town of Thurman, and the whole of Warren County, dwelling on objective measurements of assessment. That is, what is the quality of assessment in the Town of Thurman. Quality in assessment is the measure of uniformity within the assessing unit. "The chief measure of uniformity is the coefficient of dispersion (COD), which, depending on the nature of the properties involved, should not exceed 10.0-15.0 for residential properties, 15.0-20.0 for commercial properties, and 20.0 for vacant land." (p. 547, Property Appraisal and Assessment Administration. Joseph K. Eckert, Ph.D. IAAO 1990) A second measure of assessment uniformity is called the "price-related differential (PRD). I will get into the PRD a little later in this letter.

In 2018 New York State made a study of assessment quality, available on line. Appendix B-2018 Market Value Survey: Coefficient of Dispersion and Price Related Differential Report lists the results of this study for every town in the state. The COD for Thurman, 2014 All Property Sales / Appraisals was 10.83, and for 2017 Residential Sales Only was 10.01. This figure is within the IAAO standard listed above, and it is better than most of the rest of Warren County. To get a feel for this number, lets compare other towns and see how they measure up. To make this easier to understand, I am including the actual chart. For now, please just look at the COD column. At the extreme, Johnsburg has a COD of 28.50, the highest in Warren County. At the low end of the range the Town of Bolton has a lower COD of 8.36 and 8.34. Chester has a COD of 15.18 and 9.64. Just look at these numbers, the entire column, and you have to be proud of the accomplishments of the assessor in your Town of Thurman.

The next thing to study is the price-related differential (PRD). "The price-related differential is a statistic for measuring assessment regressivity or progressivity....A PRD greater than 1.00 suggests that the high-value parcels are under-appraised. On the other hand, if the PRD is less than 1.00, high-valued parcels are relatively over-appraised... As a general rule,... PRDs should range between 0.98 and 1.03." (P. 539-540 IAAO) For residential sales only, Thurman has a PRD of 1.02, matching three other towns with this figure, Glens Falls, Horicon, and Warre3nsburg. Only one town, Bolton, has a 1.00. The worst town is Stony Creek at 1.06 and

Johnsburg at 1.05. To get a better feel for this concept, I looked at the towns in Washington County and Saratoga County. Corinth has a real low PRD of 0.760n 2016 All Properties Sales Appraisals. The Town of Day has a 1.13 PRD in the same category and year as Corinth. Moreau has a PRD of 0.85 in the year 2013. Whitehall has a PRD of 1.13 for 2017 Sales Only, and 1.12 for All Property Sales/Appraisals in 2015. Whitehall also has a COD of 27.09 in 2017 Residential Sales Only.

I hope this gives you a perspective on what an assessor struggles with all the time, equality and fairness. The examples of PRDs above show problems elsewhere. Warren County PRDs as a whole is good, Thurman is exceptional. Warren County's CODs range from excellent with Bolton and Thurman, to somewhat troubling for the rest of the county, the extreme being the Town of Johnsburg.



Phantom bill haunts homeowner ong after house was leveled

your house, you're still on the hook for water bills unless you inform local officials that the structure no longer exists. Such was the case facing Town of Johnsburg officials earlier this month when confronted by a homeowner with

Councilwoman Laurie Arnheiter reported that a property

owner, who has not been identified, had received a water bill for a River Road property where the house was torn down three years ago.

The North Creek Water District bills residential property owners a flat rate of \$220.80 annually.

There are no water meters to indicate how much water is being used — if any. If the water district customer ignores the water because he or she is not using it, the amount of the bill can be attached to the property, just like unpaid taxes.

Assessor Christian Holtsaid he was aware that the house was torn down, but the property is still privately owned, and there might be plans to construct a new home there in the future.

But the property owner has never made an attempt to get the no-longer-existing house off the tax rolls or the water department's ledger, he said.

"It's all based on paper," Holt said.

The specific piece of paper the town would look for as an assessor is a "certificate of completion" issued by the Warren County Fire Prevention & Building Code Enforcement office.

That office's administrator, Charles Wallace, said if someone wants to demolish a structure, they would start by visiting their town's zoning office, which would issue a zoning compliance certificate.

The county's code office would issue a demolition permit, perform a pre-demolition and post-demolition inspection, and then issue a certificate to the applicant.

The applicant could be the property owner or the contractor doing the demolition. In either case, a copy of the certificate is sent to the town zoning office where the demolition occurred.

Without being informed of the demolition, a water bill could be issued for a property where a house was demolished.
