Supervisor Runyon called the meeting to order with the pledge to the flag.

MARK RIZZO, from **H. L. GAGE**, spoke to the town board to explain the increase in surcharges and freight charges for the new trucks purchased by the town. The price of the trucks did not change but the extra charges for freight and surcharges did. The contracts were for the trucks only and the company has no control over the freight and surcharges.

RESOLUTION TO PAY ADDITIONAL SURCHARGES AND FREIGHT CHARGES

On a motion of Supervisor Runyon, seconded by Councilman Brown, the following resolution was

WHEREAS a Local Law entitled TAX LEVY LIMIT OVERRIDE FOR FISCAL YEAR 2023 is hereby introduced, and

WHEREAS copies of the proposed Local Law have been provided to each member of the Thurman Town Board, be it

RESOLVED that the Town Board shall hold a public hearing regarding the proposed Local Law on November 03, 2022 6 pm at the Town Hall, 311 Athol Road, Athol, NY 12810 at , and

RESOLVED that the Town Clerk shall publish a public notice in the official newspaper of the Town of Thurman no later than five (5) business days prior to the public hearing.

TOWN OF THURMAN TAX LEVY LIMIT OVERRIDE FOR FISCAL YEAR 2022 LOCAL LAW NUMBER 1, 2022

A LOCAL LAW TO OVERRIDE THE TAX LEVY FOR FISCAL YEAR 2023
IN THE TOWN OF THURMAN, WARREN COUNTY, NEW YORK TO BE KNOWN AS
LOCAL LAW NUMBER 1, 2022, TAX LEVY LIMIT OVERRIDE FOR FISCAL YEAR 2023
BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF THURMAN,
WARREN COUNTY, NEW YORK AS FOLLOWS:

Section 1. Purpose. The purpose of this law is to override the Town of Thurman's tax levy limit for fiscal year 2023. It is necessary that the Town of Thurman be able

to adopt a budget requiring a tax levy greater than the tax levy limit for fiscal year 2023 because of increased costs.

Section 2. Statutory Authority. This Local Law is enacted pursuant to General Municipal Law

Section 3-C (5).

Section 3. Tax Levy Limit Override. The Town of Thurman hereby overrides the tax levy limit forfiscal year 2023 and is authorized to adopt a budget requiring a tax levy greater than that calculated according to General Municipal Law Section 3-C (3)(c).

Section 4. When Effective. This Local Law applies only to fiscal year 2023 and shall take effect upon filing with the Secretary of State.

RESOLUTION 75-2022

RESOLUTION TO RENT A POST OFFICE BOX FOR TAX COLLECTOR

On a motion of Councilman Bills, seconded by Councilman Brown, the following resolution was

ADOPTED Ayes 5 Runyon, Galusha, Bills, Needham, Brown Nays 0

WHEREAS the tax collector has expressed a need for a separate Post Office box so that she can get the town tax related mail during her working schedule, and WHEREAS the tax collector has also stated that she sometimes receives mail during months outside of the regular tax collecting time and having access to the post office on her own schedule would be more convenient for her, and WHEREAS the Post Office box should be purchased as soon as possible so that the new address is available for the upcoming town tax bills, be it RESOLVED: The Town Board authorizes the rental of a Post Office box for the Tax Collector. The fee is \$100 per year, and will be funded by a budget adjustment moving the expense from the Supervisor Contractual (A1220.4) to the Tax Collector Contractual (A1330.4).

RESOLUTION 76-2022

RESOLUTION TO ALLOW PURCHASE OF NEW COMPUTER FOR TAX COLLECTOR

On a motion of Councilman Brown, seconded by Councilman Galusha, the following resolution was

ADOPTED Ayes 5 Runyon, Galusha, Bills, Needham, Brown Nays 0

WHEREAS the tax collector has expressed a need for a replacement of her outdated computer as she is the only employee still working with Windows 7, which is not compatible with necessary software, and

WHEREAS it would be beneficial if this purchase was obtained prior to the tax year so that the necessary software can be installed and the upcoming tax bills beprinted from the new computer, be it

RESOLVED: The Town Board authorizes the purchase of a new computer for the Tax Collector for an amount not to exceed \$750.00. This amount will be funded by a budget adjustment moving the amount from the Supervisor Contractual (A1220.4) to the Tax Collector Contractual (A1330.4).

RESOLUTION 77-2022

RESOLUTION TO ALLOW PURCHASE OF TEN 8 FOOT FOLDING TABLES FOR TOWN HALL

On a motion of Councilman Needham, seconded by Councilman Bills, the following resolution was

WHEREAS the existing tables used for events in the town hall are very heavy for the residents to move, are awkward to move because they are so long, some are broken, some do not have adequate safety mechanisms, and

WHEREAS it would be beneficial to all residents using the town hall for events if newer, lighter plastic tables that fold and have a handle for moving them around, be it

RESOLVED: The Town Board authorizes the purchase of ten 8 foot plastic folding tables to be funded from the Contractual Code A1990.4

DISCUSSION: Discussion ensued regarding using SLIC internet for the towns phones.

The meals on wheels driver will be away for a while this winter so the board is interested in persons wanting to help with delivering the meals.
