RESOLUTION TO PROVIDE OCCUPANCY TAX FUNDS FOR THE TOWNWIDE GARAGE SALE

WHEREAS the Association of Towns provides educational opportunities that will benefit all elected and appointed officials, and

WHEREAS The Association of Towns is sponsoring their annual Town Finance School at the Albany Marriott Hotel May 16 th and 17 th . Topics that will be covered are Financial Condition and Report Analysis, Establishing and Accounting for Reserves, Record of Activities for Elected and Appointed Officials, and State and Federal Rules to Follow Using ARPA Funds.

RESOLVED: that the town board will permit the installation of two cameras and a motion light at the landfill. The installation and purchase of the motion light will be funded by Code A1620.4.

RESOLUTION TO ALLOW THE APPLICATION FOR A NORTHERN BORDER REGIONAL COMMISSION GRANT FOR THE PURPOSE OF AN INFRASTRUCTURE PROJECT (DIPPIKILL BRIDGE)

WHEREAS the Town Supervisor has been notified of a NBRC grant opportunity for infrastructure projects for up to \$1,000,000, and

WHEREAS the highway department has wanted to put a new bridge in on Dippikill Road because that road seasonally washes out and has required several FEMA reimbursements in the past, and

WHEREAS the highway department can provide records that would reflect the numerous repairs and reimbursement costs to FEMA that would be prevented in the future if this bridge was installed, as well as a fairly accurate cost of construction of the new bridge, be it

RESOLVED: that the Supervisor shall submit a letter of interest by April 22, 2022 at 5pm and follow up with an application by June 3, 2022 at 5pm.

DISCUSSION: Discussion ensued regarding the town website. Proposals are being gathered from website developers. The board also discussed owning a Town of Thurman Face Book Page.

DISCUSSION: Discussion ensued regarding the C + D permit.

DISCUSSION: Discussion ensued regarding the assessment of town facilities. The town board would like to have the town engineers come to a town meeting to have a discussion about town facilities and to answer questions from the board. The board discussed figuring out what the priorities are pertaining to town facilities, coming up with a long range master plan and figuring out how to finance that plan.

RESOLUTION TO ALLOW PURCHASE OF A READERBOARD SIGN

WHEREAS the sign out in front of the town hall is not working and

WHEREAS there are residents who do not have access to the website or email for notifications, and

WHEREAS the chalkboard is not adequate, especially in inclement weather, be it

RESOLVED: that the town board approves the purchase of a 48" x 72" Readerboard sign at a cost not to exceed \$6,500. This purchase is to be funded with ARPA funds-Revenue Recovery from General Fund monies spent on North Country Janitorial for cleaning services during COVID for a total of \$6,341.97. Any remaining balance will come from code A1620.4.

DISCUSSION: Discussion ensued regarding cleaning up town roads. People around town are cleaning up sections of roads and may take garbage collected from the

road to the transfer station. Anyone signing up to clean a section of road may contact Councilman Galusha to have their cleaned section put on a map on face book so people know which sections have not been cleaned yet.

DISCUSSION: Discussion ensued regarding support for Albany University's project which is developing an app that brings emergency information to underserved areas lacking internet. The board decided they would support the project and that the town hall could be used for meetings between the university and residents helping with the project.

Warren County released the Sales Tax figures for the first quarter of 2022. Thurman saw a 23.9% increase over last year. 2022 Sales Tax is 107,885.36, 2021 was 87,088.99. An increase of 20,796.37.
