**RESOLUTION TO ADOPT LOCAL LAW # 1 OF 2024
TO OVERRIDE THE TAX LEVY LIMIT**

On a motion of Councilman Needham, seconded by Councilman Brown, the following resolution was

ADOPTED Ayes 4 Runyon, Bills, Needham, Brown
Nays 0

WHEREAS the purpose of this law is to override the Town of Thurman’s tax levy limit for fiscal year 2025, and It is necessary that the Town of Thurman be able to adopt a budget requiring a tax levy greater than the tax levy limit for fiscal year 2025 because of increased costs.

WHEREAS this local law is enacted pursuant to General Municipal Law Section 3-C (5) and is attached to this resolution for your review, be it

RESOLVED that the Town Board hereby overrides its tax levy limit for the fiscal year 2025 and is authorized to adopt a budget requiring a tax levy greater than that calculated according to General Municipal Law Section 3-C(3)(c), and

BE IT FURTHER RESOLVED that this local law only applies to fiscal year 2025 and shall take affect upon filing with the Secretary of State.

TAX LEVY LIMIT OVERRIDE FOR FISCAL YEAR 2025

LOCAL LAW NUMBER 1, 2024

A LOCAL LAW TO OVERRIDE THE TAX LEVY FOR FISCAL YEAR 2025

IN THE TOWN OF THURMAN, WARREN COUNTY, NEW YORK TO BE KNOWN AS LOCAL LAW NUMBER 1, 2024, TAX LEVY LIMIT OVERRIDE FOR FISCAL YEAR 2025

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF THURMAN, WARREN COUNTY, NEW YORK AS FOLLOWS:

Section 1. Purpose. The purpose of this law is to override the Town of Thurman’s tax levy limit for fiscal year 2025. It is necessary that the Town of Thurman be able to adopt a budget requiring a tax levy greater than the tax levy limit for fiscal year 2025 because of increased costs.

Section 2. Statutory Authority. This Local Law is enacted pursuant to General Municipal Law Section 3-C (5).

Section 3. Tax Levy Limit Override. The Town of Thurman hereby overrides the tax levy limit for fiscal year 2025 and is authorized to adopt a budget requiring a tax levy greater than that calculated according to General Municipal Law Section 3-C (3)(c).

Section 4. When Effective. This Local Law applies only to fiscal year 2025 and shall take effect upon filing with the Secretary of State.
