# RESOLUTION TO APPROVE THE PURCHASE OF A 12 $\times$ 24 BUILDING FOR THE TRANSFER STATION

On a motion of Councilman Galusha, seconded by Councilman Needham, the following resolution was

**WHEREAS** the Town of Thurman is in the process of moving the Transfer Station from one side of the property to the other and it is necessary to remove the small building that exists on this site, and

WHEREAS this small building is in bad shape and should be replaced, and

**WHEREAS** there is a  $12 \times 24$  building in Warrensburg that has a 4 foot deck for the scale to be located, is already built and comes with free delivery and set up for a total amount of \$8,185.50. This building is less expensive than the two car garage kit purchase the Town Board discussed in June 2023, which was \$12,000 and would require a foundation and construction. Therefore, be it

**RESOLVED** that the Town Board hereby authorizes the purchase of a 12 x 24 building costing

\$8,185.50, to be paid for from A1990.4 Contingency Account which has a current balance of \$10,700.
